## NOTES

### Introduction

This declaration must be completed and returned to the Greffier of the States within 30 days of your election or re-election. The requirement to register applies to all interests, whether received, arising, held or owned within or outside Jersey. Please note that there is no requirement to register the monetary value of any interest that must be registered but you may do so if you wish.

If the requirement to register any interest on this form depends on its having a monetary value in excess of a specified amount (e.g. shareholdings) and you are unsure of the exact value of the interest, but believe it to be in the region of the specified amount, you must register it.

Certain sections require you to register interests of your 'spouse or cohabitee'. For these purposes you are not required to declare any interests of a former spouse or a spouse who is living separately and apart from you. Standing Orders define 'cohabitee' as a person of either sex living with an elected member in a relationship similar to that of husband and wife. You are not required to register any interest of your spouse or cohabitee which you are not aware of.

### Notes on particular sections

- 1. Employment, offices, directorships and partnerships**
  - i) You are not required to give any details of the amount of remuneration received for any of the entries in this section.
  - ii) If you are a director of a company by which you are not remunerated, but receive remuneration through another company in the same group, the directorship must be registered.
  - iii) You are not required to register –
    - (a) remuneration you receive from the States of Jersey by virtue of being an elected member; or
    - (b) remuneration you receive out of the funds of a parish by virtue of being its Connétable.
  
- 2. Self-employment etc.**

You are not required to give any details of the monetary value of any income received from self-employment, consultancy, etc.
  
- 3. Shareholdings**
  - i) You are only required to register the names and details of the companies in which you have a declarable interest and are not required to specify the monetary value of your shareholding.
  - ii) For the purposes of this section, you are deemed to own shares if you own them in your own name or if

the shares are held on your behalf, or for your benefit, by any other person.

- 4. Sponsorship** You are **not** required to give any details of the monetary value of any sponsorship or benefit received.
- 5. Gifts, Hospitality and other benefits**
- i) For the purposes of this section the value of gifts, hospitality or other benefit which must be registered is £426.00 (2014 remuneration level).
- You are not, however, required to provide any estimate of the value of the gift, hospitality or benefit received.
- ii) You are not required to register any gift, hospitality or other benefit which is given or made available to all elected members or to all spouses or cohabitants of elected members.
- 6. Overseas Visits** You are not required to register any visit paid for by the States or any administration of the States. Members should nevertheless register visits where the cost is met by other organisation.
- 7. Land** Under the provisions of the Interpretation (Jersey) Law 1954 the word 'land' includes houses and other buildings and you must therefore register all details of all property in the categories set out.

The information you provide as required under Standing Order 152 and Schedule 2 of the Standing Orders of the States of Jersey will be processed by the States Greffe Department as the Data Controller in accordance with the Data Protection (Jersey) Law 2018 for the purposes associated with the administration of the Standing Orders of the States of Jersey.

Failure to provide the information will result in a referral to the Commissioner for Standards and may result in the Commissioner imposing some form of sanction.

In addition a copy will also be uploaded to the States Assembly website. Where requested, copies will be provided to members of the public. The States Greffe, when notified of any changes you have made to your Statement, will ensure that the amended copy is available for public inspection and is uploaded to the States Assembly website.

Previous versions of Statements, both for current elected members and previously elected members, will be kept on a permanent basis by the States Greffe and will be made available to the public on request.

### **Your rights**

You have the right to apply for a copy of the personal data we hold about you and to have any inaccurate personal data about you rectified. In addition, in some circumstances you may also have the right to request that we erase or restrict processing of your personal data.
