The Bailiff, in accordance with the provisions of Standing Order 82, ordered all strangers to withdraw from the precincts of the States and the doors of the Chamber to be closed.

THE STATES, having concluded the debate *in camera*, proceeded to vote in public assembly and agreed, in pursuance of Article 3 of the Financial Services Commission (Jersey) Law 1998 to appoint Mr. John Richard Harris as a Commissioner of the Jersey Financial Services Commission with effect from 1st March 2010 to 28th February 2013.
