Transfer of Undertakings Protection of Employment legislation P.60/2012

THE STATES rejected a proposition of Deputy G.P. Southern of St. Helier to request the Minister for Social Security to bring forward for approval by the Assembly, no later than the first quarter of 2013, legislation for the protection of employees involved in business mergers and acquisitions (Transfer of Undertakings Protection of Employment 'TUPE' legislation) and, provided that the draft legislation was approved by the States, sanctioned by Her Majesty in Council and registered in the Royal Court in time, to take all necessary steps to bring the legislation and any necessary subordinate legislation into force no later than December 2013; and to request the States Employment Board, to refrain from reaching any final agreement on schemes to privatise or outsource services currently delivered by the public sector until the legislation referred to in paragraph (a) was in place.
