THE STATES, having been informed that the relevant scrutiny panel had indicated that it did not wish to scrutinise the draft legislation, adopted Article 1.

THE STATES commenced consideration of Article 2 and, adopting an amendment of the Chief Minister, agreed that -

- (1) In paragraph (a), in the substituted paragraph (1), for the words "the Ministers" there should be substituted the words "at least 7 Ministers".
- (2) After paragraph (c) the following paragraph should be added
 - "(d) after paragraph (5) there shall be added the following paragraph
 - '(6) The States may by Regulations amend the minimum number of Ministers in paragraph (1).' ".

THE STATES, adopting paragraph (1) of an amendment of Deputy John Alexander Nicholas Le Fondré of St. Lawrence to Article 2, agreed that in paragraph (c), in the inserted Article 18(3A)(b) after the words "agree and" there should be inserted the words ", within 3 months of being appointed to office under Article 19(7)," upon the States approving the proposal or nomination."

THE STATES, adopting an amendment of Deputy Tracey Anne Vallois of St. Saviour to Article 2, agreed that in paragraph (c) in the inserted paragraph (3A)(b) after the words "a code of conduct" there should be inserted the words "and a code of practice".

THE STATES commenced consideration of Article 3 and paragraph (1) of an amendment of the Connétable of St. Mary that for Article 3 there should be substituted the following Article –

"3 Article 19 amended

In Article 19 –

- (a) for paragraphs (3) to (5) there shall be substituted the following paragraphs
 - '(3) The Chief Minister designate shall decide and, in accordance with the prescribed procedures and within the prescribed periods, announce his or her decision as to
 - (a) the elected members to be appointed as Ministers; and
 - (b) the Ministerial office to which each of them is to be assigned.
 - (4) Before making a decision and announcement under paragraph (3), the Chief Minister designate may, in accordance with the prescribed procedures and within the prescribed periods, propose the establishment or abolition of Ministerial offices.
 - (5) A proposal under paragraph (4)
 - (a) must describe the functions of any new Ministerial office; and
 - (b) must indicate the Minister to whom the functions of any abolished Ministerial office would be transferred.
 - (5A) The States may not amend a Chief Minister designate's proposal under paragraph (4).';
- (b) for paragraph (7) there shall be substituted the following paragraph
 - '(7) The Chief Minister designate and the persons decided by him or her for appointment as Ministers are appointed to office upon the conclusion of his or her announcement of his or her decision under paragraph (3).'."
