# Future Hospital: preferred site P.110/2016

THE STATES commenced consideration of a proposition of the Council of Ministers entitled 'Future Hospital: preferred site' (P.110/2016).

THE STATES noted that, in accordance with the provisions of Standing Order 106(1)(b), the Deputy of St. Martin declared an interest and withdrew from the Chamber for the duration of the debate.

THE STATES commenced consideration of an amendment of the Connétable of St. John (P.110/2016 Amd.) that –

(1) After the words "new General Hospital" there should be inserted the words –

"either -

(a) ".

(2) For the words "this Proposition," there should be substituted the words –

"this Proposition; or

- (b) the south side of the Waterfront site, not including any part of Les Jardins de la Mer, in accordance with the Map in the Appendix to the Report accompanying this Amendment,".
- (3) For the words "proposals to be brought back to the Assembly as set out in Section 6.3 of the accompanying Report" there should be substituted the words –

"business cases for both options to be brought back to the Assembly by the summer recess in 2017; and".

(4) After paragraph (b), there should be inserted the following paragraph –

"to request the Minister for the Environment to amend the Esplanade Quarter Masterplan to make provision for the potential siting of a new hospital on the south side of the Waterfront.".

#### Adjournment

THE STATES adjourned, having agreed to reconvene on Thursday 1st December 2016 to continue consideration of the proposition of the Council of Ministers entitled 'Future Hospital: preferred site' (P.110/2016) and the amendment of the Connétable of St. John.
