- (a) to agree that legislation to change the composition and election of the States Assembly arising from Proposition P.133/2016 as amended, agreed in principle on 2nd February 2017, should only come into force if it won the support of the majority of Islanders who voted in a YES/NO referendum, to be held before the end of 2017;
- (b) to request the Privileges and Procedures Committee to bring forward an Act for a referendum and to consult independent experts to ensure that the wording of the question put to the electorate was fair and unbiased.
