Taxation (Implementation) (International Tax Compliance) (Common Reporting Standard) Regulations (Jersey) Amendment Order 2024.

Minister for External Relations.

This Order amends the Taxation (Implementation) (International Tax Compliance) (Common Reporting Standard) (Jersey) Regulations 2015 (“the Regulations”) to add and remove entries from the tables of participating jurisdictions in Schedules 2, 3 and 4 to the Order.

Article 2 amends the table in Schedule 4. This adds entries for Jamaica, Kenya, New Caledonia and Thailand. The relevant date for the purpose of Regulation 3 of the Regulations for of these new entries is 31st December 2022 and the relevant year for the purposes of Regulations 5 and 8 is 2023.

Articles 3, 4 and 5 delete Anguilla and Monserrat from the table in Schedule 2, Niue and Trinidad and Tobago from the table in Schedule 3 and Liberia and Morocco from the table in Schedule 4.

The amendments in *Article 2* come into force the date after the Order is made and the amendments in *Articles 3, 4 and 5* come into force on 1st July 2024.
