REPORT

The United Nations Convention on Recovery Abroad of Maintenance (1956) is designed to facilitate the recovery of maintenance to which a person, who is in the territory of one of the Contracting Parties, claims to be entitled from another person who is subject to the jurisdiction of another Contracting Party.

The Maintenance Orders (Facilities for Enforcement) (Jersey) Law 2000 was enacted to make provision to facilitate the enforcement of maintenance orders; to make provision for the extension to Jersey of the United Nations Convention on the Recovery Abroad of Maintenance done at New York on 20th June 1956, and the Convention on the Recognition and Enforcement of Decisions Relating to Maintenance Obligations done at the Hague on 2nd October 1973; and for connected purposes.

The Maintenance Orders (Facilities for Enforcement – Convention Countries) (Jersey) Act 2003 identifies which Convention countries and territories the United Nations Convention on Recovery Abroad of Maintenance done at New York on 20th June 1956 extends for the purposes of the Maintenance Orders (Facilities for Enforcement) (Jersey) Law 2000.

The Maintenance Orders (Facilities for Enforcement – Convention Countries) (Amendment) (Jersey) Act 201- amends the Maintenance Orders (Facilities for Enforcement – Convention Countries) (Jersey) Act 2003 so that claimants in Jersey can pursue individuals in Ireland for maintenance payments.

Financial and manpower implications

There are no financial or manpower implications for the States arising from the adoption of this draft Act.

Explanatory Note

This Act amends the Maintenance Orders (Facilities for Enforcement – Convention Countries) (Jersey) Act 2003 by adding Ireland to the list of convention countries to which the United Nations Convention on the Recovery Abroad of Maintenance done at New York on 20th June 1956 extends for the purposes of the Maintenance Orders (Facilities for Enforcement) (Jersey) Law 2000.
