REPORT

The Minister for Education ("the Minister") is requesting an amendment to the Education (Jersey) Law 1999 ("the Law") to replace the Regulation-making power in Article 3(4) of the Law with a power for the Minister to amend Schedule 1 to the Law by Order.

Granting the Minister the power to change, within Schedule 1 (Article 3) of the Law, or remove from Schedule 1, the name of a Provided School by Order, will result in a more efficient and appropriate way for such changes to be made in the future.

Financial and manpower implications

There are no financial or manpower implications for the States arising from the adoption of this draft Law.

Human Rights

No human rights notes are annexed because the Law Officers' Department has indicated that the draft Law does not give rise to any human rights issues.

Explanatory Note

By *Article 1* of this draft Law, the Regulation-making power in Article 3(4) of the Education (Jersey) Law 1999 would be replaced by a power for the Minister to amend Schedule 1 to that Law by Order.

Article 2 would provide for the title by which this Law may be cited, and for its commencement immediately upon registration.

THE STATES, subject to the sanction of Her Most Excellent Majesty in Council, have adopted the following Law –

1 Education (Jersey) Law 1999 amended

In Article 3 of the Education (Jersey) Law 1999¹, for paragraph (4) there shall be substituted the following paragraph –

"(4) The Minister may by Order amend Schedule 1.".

2 Citation and commencement

This Law may be cited as the Education (Amendment No. 3) (Jersey) Law 201-and shall come into force immediately after it is registered.
