The new Articles have a number of benefits including being in accordance with modern corporate governance standards and being largely consistent with the Articles of other States-Owned Entities and are not being adopted as a result of any specific problem or issue.</p>

<p>The proposed new Articles of Association simply govern the internal corporate governance and operations of the Board of Directors of Andium Homes and the Company itself. Since this is largely administrative in nature, no group of children and young people are likely be affected.</p>
