**Public Health Committee: capital projects for 1986. P.61/85.**

THE STATES, adopting a Proposition of the Public Health Committee –

1. approved the further investigation of the development of Staff Residential Accommodation for nurses and medical staff employed by the Jersey Group of Hospitals.
2. approved in principle –
  - (a) the construction of an additional floor above the west wing of the Gwyneth Huelin Wing at the General Hospital to accommodate the Department of Clinical Investigation and additional Out-Patient Clinics;

- (b) the redevelopment of the Limes Hospital site for construction of 12 units of Sheltered Housing;
- (c) the extension and up-grading of the X-Ray and Accident Departments at the General Hospital under Phase 3 of the redevelopment programme.

**Les Quennevais Playing Fields: Phase III development. P.62/85.**

THE STATES, adopting a Proposition of the Education Committee, approved in principle Phase III of Les Quennevais playing fields development.

**Primary Schools: improvements. P.63/85.**
