The Telecommunications Board by Act dated 25th April, 1986, presented to the States its Report for the year ended 31st December, 1985.

#### Matter noted – financial transaction.

THE STATES noted an Act of the Finance and Economics Committee dated 28th April, 1986, showing that in pursuance of Rule 5 of the Public Finances (General) (Jersey) Rules, 1967, as amended, the Committee had noted that the Harbours and Airport Committee had accepted the lowest of nine tenders, namely that submitted by Shephard Hill and Company Limited in the sum of £9,160,495.57 in a contract period of 117 weeks for the construction of a fish quay and slipway, and new roll-on/roll-off berths at the Port of St. Helier.

Draft Protection of Employment Opportunities (Jersey) Law, 198. P.36/83. Withdrawn.

THE STATES acceded to the request of the President of the Defence Committee that the draft Protection of Employment Opportunities (Jersey) Law, 198 (lodged on 15th March, 1983) be withdrawn as a revised draft Law had been lodged at the present Sitting (P.94/86).

Defence contribution and international representation: second report of Special Committee. Committee of the Whole House. P.70/86.

THE STATES, on the proposition of the President of the Special Committee, resolved into a Committee of the Whole House to discuss the Second Report of the Special Committee to consider a request from the United Kingdom Government for a contribution towards defence and international representation.

The Committee adjourned at 6.30 p.m. until 2nd July, 1986.
