Advocates Law: amendment. Statement

The President of the Legislation Committee made

``As was made very clear when the House was considering the introduction of the Caen requirement as long ago as 1989 the legal profession is not united about the merits of attendance at Caen University. Almost all lawyers are however agreed that the Norman origins of our law are an important part of our heritage and of our legal system, and that students should have a thorough grounding of knowledge of Jersey Customary Law. It is only in the means to achieve that end that there is disagreement. My Committee accepted the unanimous recommendation of the working party of advocates and solicitors chaired by the Attorney General that students should be required to obtain, as in Guernsey, the Certificat d'Etudes Juridiques Françaises et Normandes. A number of other suggestions have however recently been made by individual lawyers one of which is that local lawyers should themselves provide a regular series of lectures for the benefit of students. My Committee considers, in the light of the strong feelings expressed by some members of the legal profession, that these other options should be examined carefully before the House is asked to consider any further amendment to the Advocates Law. My Committee will therefore hold discussions with the Law Society, the University of Caen and any other interested parties so as to conduct a review of the requirement introduced in 1989.

As a matter of courtesy, to put it at its lowest it seems to my Committee that the University with which the Island made an agreement some time ago, should be consulted before any precipitate action is taken.

I accordingly propose to defer the debate on my Committee's proposition and I have given notice to the Greffier accordingly. As soon as my Committee has had the opportunity to conduct the review to which I have referred I shall report fully to the House which will then have the opportunity to debate these interesting but complicated issues."
