Jersey Royal potatoes. Questions and answers (Tape No. 144)

Senator Richard Joseph Shenton asked Senator Nigel Lewis Quérée, a member of the Agriculture and Fisheries Committee the following questions -

``1. Will the President inform the House of the breakdown in costs

associated with shipping one tonne of Jersey Royal potatoes to the United Kingdom using Lo-Lo facilities at Jersey and Portsmouth; the breakdown to include the costs of sea freight, stevedoring charges at both ends, harbour dues, the cost of pallets, packaging in Jersey, road transport in Jersey, road transport in the United Kingdom, commissions and any other relevant charges?

- 2. Will the President inform the House as to the total value of the 1992 Jersey Royal exports to date and express the costs as a percentage per tonne of the total value?
- 3. Will the President inform the House as to the total number of vergées of arable land in Jersey that is used for potato production only?"

Senator Quérée replied as follows -

"Senator Shenton's questions enable the Agriculture and Fisheries Committee to inform the House that it has already decided to undertake a survey into distribution and marketing charges as well as margins at outlets. There are a number of elements that make up the charges and these replies detail the result of the Committee's first investigations but have, as yet not been compared to marketing costs in other areas.

- (b) Commission rate 6 per cent to whol esalers plus a further 1.5 per cent as marketing charges
- (c) Other charges -

insurance 0.6 per cent group levy 0.1 per cent.

Several points must be borne in mind in looking at these costs.

- (a) Jersey harbour dues on produce exported are refunded in part by the States. In 1991 the figure was £3.65 a tonne refund on all produce exported.
- (b) The promotion activity fund levy is financed from within the Committee's promotion and advertising votes and refunded to growers.
- (c) The marketing groups have to decide on a freight rate before the season commences, i.e. total weight, likely peaks length of the season and the detailed distribution pattern are not known. Thus in some years there is an element of rebate on these costs by some groups.
- (d) The road freight cannot be assessed in simple terms as it represents the cost of achieving a delivery aligned to market requirements necessitating for example part load deliveries and loadings designed to meet supermarket delivery slots.

The freight rate also includes refrigerating potatoes and storing potatoes in refrigerated conditions, when necessary, and also includes all overtime rates incurred in Jersey and Portsmouth docks.

It will be noted that the total costs of an individual consignment sent by Lo-Lo mid week and delivered to an adjacent market would undoubtedly be less than the £61.80 quoted. The reasons for the higher standard cost are outlined above.

- (e) Packing charges include all overtime and packing on public holidays and weekends.
- 2. The full value of the season is not yet known. However it is known that 49,657 tonnes had been exported up to 30th June. The United Kingdom gross value on the first 27,204 tonnes was £12,119,201. Bearing in mind the answers to question 1 the costs would be approximately 30.5 per cent of the value. Since that time prices have fallen and thus handling, etc. becomes a large percentage of the value.
- 3. No records are available of the specific uses of areas of land. What is available are the areas devoted to various crops and the income attributed to those crops. The table clearly indicates the industry's increasing reliance on the Jersey Royal over the last few years land usage is similar to that of the early sixties but financially the dependance on the Jersey Royal has increased to almost 60 per cent of total exports.

Comparative Study of Salaries and Wages in the Private Sector. Questions and Answers (Tape No. 144)

Deputy Alan Payn Bree of Grouville asked Senator Richard Joseph Shenton, President of the Establishment Committee the following questions -

- "With reference to the `Comparative Study of Salaries and Wages in the Private Sector' carried out last year by the United Kingdom Consultants, P.E. International, will the President of the Establishment Committee kindly inform this House -
- (a) When was the contract to carry out the study let to P.E. International?
- (b) When was the report of the Consultants received by the Committee?
- (c) When will it be made available to States' Members?"

The President of the Establishment Committee replied as follows -

- "(a) P.E. International Plc were informed on 21st January 1991.
- (b) The first draft was received on 23rd July 1991. A final draft is still awaited.
- (c) When the Establishment Committee is satisfied that the terms agreed with P.E. have been met it will be made available, as originally agreed, to the

Civil Service Staff Side and private sector organisations which participated in the survey."

# Change of Presidency

The Sitting continued under the Presidency of the Bailiff.

### Postal services. Statement

The President of the Committee for Postal Administration made a statement in the following terms -

"My Committee would wish the House to be aware of the difficulties Postal continues to face in attempting to follow States policy, with particular regard to zero job growth, against a background of increasing volumes of mail.

In order to operate a high level of service for the businesses and public of the Island, against a background of manpower and financial constraint, there is a need to review methods and work practices and this includes the introduction of mechanisation. Change is commonly met with resistance, in this respect Postal is no different and considerable difficulties are being experienced.

The Establishment Committee has been both informed and involved in the discussions between the Postal Committee and the Union of Communication Workers. Satisfactory progress with the discussions has been helped by the intervention of the Deputy General Secretary of the Union who spent several days in the Island on two occasions in the past few months.

In any large work force there is always a small element who will act in a way to compound difficulties and again the Postal Department is no exception. This has caused embarrassment to the Department and inconvenience to the public of the Island. Such problems can only be resolved in-house and are not helped by misinformed media attention. Although it will not come as a surprise to Members to learn of the increasing amount of mail incoming to the Island, so far this year another 10 per cent, many Members may not appreciate that we now handle over one million items per week. Coupled with the growth in the number

of addresses it says much for management that we have been able to provide the level of service without taking on extra staff.

The saddest part of this unfortunate episode is that at a time when there is a need to modify attitudes and moderate expectations throughout the public sector we were being attacked by the Jersey Evening Post who invited criticism in order to fill their pages and who expected my Committee to openly debate the issue which had become extremely delicate.

Thanks to the co-operation of the many loyal staff and the Union of Communication Workers, who recognise their responsibilities, we now have a climate within which the recently introduced mechanisation can be used in a productive manner and so help contain costs and high levels of overtime in an operation that is essentially labour intensive.

It is hoped that the House will appreciate the difficulties that the Postal Department faces and will continue to support us in carrying out States policies, which in the long term will be of benefit to the postal user."

Access to premises and related facilities. Statement

The President of the Island Development Committee made a statement in the following terms -

`Members of this House will be aware that in addition to planning services my Committee provides a comprehensive building control service to the Island. One of its objectives is to ensure that all new building construction work complies with legislation and good building practice. The public is fortunate in being able to rely on my department's professional expertise which, in my Committee's view, has over the years generally resulted in a great improvement in the quality of building standards in the Island.

In 1961 we were given the legal authority of the Public Health (Control of Building) (Jersey) Law 1956 to carry out this work. The purposes of this Law are very clearly set out in detail in Article 2 which defines the powers available to the Committee to make Bye-laws. There are

currently in place 128 Bye-laws whose revision is now well advanced. It was identified that a serious gap existed in the Law's provision for access and facilities for disabled persons. In the modern world it is imperative that we find ways of enabling all members of our community to lead as full a life as is possible.

My officers, aided by Mr L. Davis an adviser to the U.K. government, have now completed a draft of the requirements of new Bye-laws for access for the disabled which my Committee intends to introduce. We have requested the Attorney General to advise whether the purposes in the existing Law are sufficiently wide to empower these draft Bye-laws, of which there is some doubt.

We have, therefore, decided to issue these Bye-laws as a code of practice in advance of my Committee obtaining the necessary amendments to the Law.

Members of the House have today received a copy of the draft code of practice which is being issued for consultation by architectural practices. It will then become a voluntary code of practice to which we would ask all development applications for public buildings to conform to, including particularly all new construction work to States buildings.

My Property Services Department will be endeavouring with the Public Services Department to try to advance plans for improved access to existing States buildings wherever possible. This requires resources which we have every confidence the States will provide in due course.

I would like to record my Committee's gratitude for the help we have received from the staff at Overdale and the Disabled Access Group in the preparing of this code which I am sure will be of help to all those involved."

Territorial Army Centre, La Collette: purchase and sale of land

THE STATES, adopting a proposition of the Defence Committee -

(a) referred to their Act dated 9th April 1991 regarding the purchase and sale of

land at La Collette and agreed to the cession from the Parish of St. Helier of 11 perch of land, as shown on plan number 2191/2 free of charge;

Strategic policy report for 1992. P.70/92

THE STATES, adopted an amendment (P.87/92) of the Housing Committee that in paragraph 7, after sub-paragraph (c) there should be inserted the following sub-paragraph -

"(d) to request that the Finance and Economics committee makes every endeavour to grant in 1993 appropriate financial assistance to housing associations which the Housing Committee permits to develop certain of the sites under its administration."
