The existing paragraph (c) should be relettered paragraph (d).

The subsequent paragraphs should be relettered.

THE STATES, adopting the proposition of the Planning and Environment Committee, referred to their Act dated 8th June 1993 approving a development plan designating Springfield, St. Helier, for sports, leisure, recreation and community purposes, and to their Act dated 8th November 1994 approving the purchase of approximately 244,000 square feet of land at Springfield, St. Helier, as shown on drawing No. 383/1, from the Royal Jersey Agricultural and Horticultural Society, and -

- (a) approved the purchase on behalf of the public, from owners(s) whose identity was at present unknown, of an area of roadway known as Springfield Lane (formerly Janvrin Lane), St Helier, measuring approximately 338 square metres, as shown on drawing No. 479/1, and authorised the Greffier of the States to sign the said drawing on behalf of the States;
- (b) authorised the Planning and Environment Committee to negotiate with the owner(s), if it was possible to establish their identity, for the purchase of the said land at a fair and proper price to be agreed by the Finance and Economics Committee;
- (c) agreed that if it were not possible to agree a fair and proper price with the owner(s), either because it was not possible to establish their identity or for any other reason, the Planning and Environment Committee should be empowered, in exercise of the powers conferred by Artice 4 of the Island Planning (Jersey) Law 1964, as amended, to acquire the land by compulsory purchase, in accordance with the provisions of the Compulsory Purchase of Land (Procedure) (Jersey) Law 1961, as amended;
- (d) authorised the Attorney General and the

Greffier of the States to pass on behalf of the public any contracts which it might be found necessary to pass in connexion with the purchase of the said land and all interests therein;

- (e) authorised the payment or discharge of the expenses incurred in connexion with the purchase of the said land, and all interests therein, from the Planning and Environment Committee's capital vote of credit - `Acquisition of Land -Major Reserve' (Vote No. C.0904);
- (f) authorised the transfer of the administration of the land, once acquired, to the Sport, Leisure and Recreation Committee.
