Matters noted - land transactions

THE STATES noted an Act of the Finance and Economics Committee dated 13th May 1996, showing that, in pursuance of Standing Orders relating to certain transactions in land, the Committee had approved -

- (a) as recommended by the Health and Social Services Committee, the sub-lease to Servain Limited by Mr. Maurice George Vowden and Mrs. Eileen Maria Vowden, neé Bulman, of 52 Don Street, St. Helier, for the remaining portion of the Head Lease until 24th June 1998;
- (b) as recommended by the Health and Social Services Committee, the renewal of the lease from Mr. Christian John Langlois and Mrs. Christine Louise Langlois, née Holborrow, of the three-bedroom property 2 Bel Royal Gardens, St. Lawrence, for a period of one year from 16th February 1996 at an annual rent of £10,640;

- (c) as recommended by the Planning and Environment Committee, the review of rent in accordance with open market values with effect from 25th December 1994 in respect of the 25-year lease from 29th September 1984 to Messrs. Andrew Le Gallais and Paul Houzé of Field No. 107, Maufant Road, St. Saviour (measuring 18.6 vergées), an annual rent of £1,250 payable in advance;

Relocation of d'Hautrée School - questions and answers (Tape No.339)

Senator Corrie Stein asked Deputy Evelyn Mabel Pullin, President of the Education Committee, the following questions -

- Does the President agree that on 22nd October 1991 the States adopted a proposition of the Education Committee `The Future of Secondary Education' (P.149/91), which included strategic plans for the following ten years, and that as part of that Plan the States approved in principle `the relocation of d'Hautrée School', also that on 29th September 1993, the States adopted a proposition of the Island Development Committee `D'Hautrée School: rezoning and purchase of land (P.117/93)'?
- 2. Would the President agree that two previous Education Committees have given assurances to the teachers of d'Hautrée School that they would move with the school to the relocated St. Anne's School?"

The President of the Education Committee replied

- "1. Yes. It is a matter of record that the States agreed to the relocation of the d'Hautrée School building to part of Fields Nos. 1243 and 1244, St Helier.
- 2. Yes. The previous two Education
  Committees decided to transfer staff to
  the new school building and the school
  staff at that time were so informed. A
  decision was taken by the present
  Education Committee to open posts to
  general application within the service
  after discussions had taken place with
  the Chairman of Governors who indicated
  his support for our proposal.

With the Vice-President and the Director I had helpful discussions with staff representatives last week which led to some sensible and practical proposals which it is hoped will reach agreement on both sides. These suggestions will be taken to the full Education Committee on Wednesday, 22nd May 1996, and provided they are accepted and are agreed by teachers and Governors, I will be in a position to make a full statement."

Clinical waste incinerator: approval of drawings - P.85/96

THE STATES commenced consideration of a proposition of the Public Services
Committee requesting approval of a drawing showing the conceptual design layout of the clinical waste incinerator to be located at Bellozanne, St. Helier. After discussion, and on the proposition of Senator Stuart Syvret, the proposition was lodged ``au Greffe".
