THE STATES noted an Act of the Finance and Economics Committee, dated 13th October 1997, recording the following decisions of the Treasurer of the States under delegated powers, in pursuance of Standing Orders relating to certain transactions in land -

(a) as recommended by the Health and Social Services Committee, the renewal of the lease from Macpor Development Company Limited of Flat 1, 29 Midvale Road, St. Helier, required for the continued occupation by a speech therapist, for a period of 12 months from 1st October 1997, at an annual rent of £6,820.65, with all other terms and conditions remaining the same as the existing lease, on the basis that each party would be responsible for its own legal costs arising from this transaction;

- (ii) a ticket desk (Letting No. D003) in the John Le Fondré Departure Hall, Jersey Airport, measuring approximately 154 square feet, for a period of nine years from 1st April 1997, at an annual rent of £5,000 subject to annual rent reviews on 1st April;
- (f) as recommended by the Harbours and Airport Committee, the assignment of the lease from Esso Petroleum Limited (Esso) to Fuel Supplies (C.I.) Limited (Shell) of the Fuel Farm at Jersey Airport;
- (g) as recommended by the Harbours and Airport Committee, the lease to Channel Island Tourist Services Limited of 345 square feet of accommodation in the first floor of the building known as Alares House, Jersey Airport, for a period of three years from 1st September 1997, at an annual rent of £3,795, subject to annual rent reviews on 1st September, on the basis that the lease was to be reviewed at six monthly intervals by the Committee with regard to the demolition of Alares House for the development of a one-way road system;

States' members remuneration - questions and answers (Tape No. 409)

Deputy Frederick John Hill of St. Martin asked Deputy Derek Ryder Maltwood of St. Mary, President of the House Committee, the following questions -

- ``1. On 6th May 1997, the report of the States Members' Remuneration Board was released to enable the House Committee to bring a proposition before the States. Would the President inform members -
 - (a) what steps have the House Committee taken to produce a proposition?
 - (b) when does he expect a proposition to be presented to the States?
- 2. The House Committee has been in the process of producing a States Members' Handbook. Would the President inform members of the progress of the production and when it will be completed?"

The President of the House Committee replied as follows -

1. I regret that the Deputy of St. Martin has had to ask these questions as it had been the intention of the House Committee to lodge this proposition several months ago.

The position is that the House Committee decided to present to the States a report and proposition seeking approval of the recommendations of the Board. However, some complications then arose with the administrative procedures of the Scheme, but I am pleased to report that these have now been resolved. Therefore, I envisage that the House Committee will approve the report and proposition at its meeting on 30th October. They will then be lodged `au Greffe' through the intermediary of the Finance and Economics Committee and I would expect that the proposition will be debated on 9th December 1997.

2. The Members' Handbook is at last on the verge of publication. I envisage that the final draft will be approved by the House Committee at its meeting on 30th October 1997. In which case, it will then be prepared for publication and distributed as soon as possible thereafter.

In case I do not have a better opportunity, I would like to thank all those who have been involved in its preparation. A considerable amount of work and research has been undertaken by a number of people and, on behalf of the House Committee and fellow members, I would like to express my sincere gratitude to them."

Cost of interpreters - question and answer (Tape No. 409)

Deputy Philip John Rondel of St. John asked Deputy Michael Adam Wavell of St. Saviour, President of the Defence Committee, the following question -

"Would the President inform members of the cost to the States of Jersey Police of employing interpreters during 1996, and provide similar details for the years, 1992 and 1994?"

The President of the Defence Committee replied as follows -

"The costs to the States of Jersey Police of employing interpreters since 1992 are as follows -

1992	£2,744
1993	£12,193
1994	£18,670
1995	£24,786
1996	£31,158
1997 to date	£27,431

These costs include the use of interpreters for all nationalities."

Jersey Arts Trust - statement

The President of the Education Committee made a statement in the following terms -

"Following questions asked of me by Deputy Vibert on 7th October 1997, I undertook to make a statement to the House concerning the issues raised in his first question which was -

`Will the President inform the Assembly of the progress that has been achieved by the Jersey Arts Trust against its stated targets for the years 1996 and 1997, which were included in its Five Year Plan, presented to the States on 9th July 1996 as part of P.114/96 `Jersey Arts Trust: future funding'?'

As I confirmed at the time, I had contacted the Chairman of the Arts Trust, Sir Peter Crill, to obtain the information requested by Deputy Vibert. I received a comprehensive response from Sir Peter which I have circulated to all members. I would draw the attention of members to Sir Peter's willingness and commitment to provide any further details requested by them.

For the sake of clarity, I would like to remind members of the status of the Arts Trust and of the relationship which exists between the Trust and the Education Committee.

The Arts Trust was established by an act of incorporation by the Royal Court.

As such the Jersey Arts Trust was authorised to -

Take, acquire, hold and possess in its corporate name all forms of property both real and personal and wheresoever situated in order that the objects of the Association may be achieved.

The Trust is an incorporated body with wide ranging powers and duties. Under its Constitution, the Arts Trust has the following responsibilities to the Education Committee -

- (i) to advise and co-operate with the Education Committee on matters connected with the Arts;
- (ii) liaise with the Education Committee on the provision of education opportunities and events involving arts and crafts.

The Education Committee also has responsibilities to the Trust. These are -

- 1. to recommend to the States a person who may be appointed as Chairman; however, it is the States that make that appointment;
- 2. to nominate a member of the Education Committee to act as Vice Chairman of the Trust:
- 3. to consider and approve or reject alterations to the Trust's constitution proposed by a majority of its members; while the Committee has a role in approving amendments to the constitution of the Trust, it is the responsibility of the Trust to make representations to the Royal Court for amendments to its constitution.

I trust that this clarifies any misconceptions which may have been held by members concerning the status of the Trust and the extent of my Committee's responsibilities towards it. However, I am willing to use my best endeavours to assist in resolving present difficulties and I will continue to give my support to those who give so much of their time and energy to supporting the Arts in Jersey."

Jersey Arts Trust - questions and answers (Tape No. 409)

Deputy Michael Edward Vibert of St. Brelade asked Senator Leonard Norman, President of the Education Committee, the following questions -

``1. Is the President now in a position to, and will he now, answer my question of two weeks ago regarding the progress that has been achieved by the Jersey Arts Trust against their stated targets for the years 1996 and 1997 which

were included in the Trust's Five Year Plan which was presented to the States on 9th July 1936 as part of the Finance and Economics Committee's proposition `Jersey Arts Trust: future funding' (P.114/96)?

2. Will the President also inform the members as to the latest situation regarding the Jersey Arts Trust's restructuring proposals for the arts in Jersey?"

The President of the Education Committee replied as follows -

"1. On 7th October, I replied to Deputy Vibert's first question to the best of my knowledge and ability. I indicated my understanding that the question should have been asked of the Chairman of the Arts Trust and that, on behalf of Deputy Vibert, I had contacted Sir Peter to secure his response.

I have received a comprehensive reply from Sir Peter which I have circulated to all members. In his letter, Sir Peter confirmed his willingness and commitment to provide any further details requested by any member of the House."

Senator Patricia Ann Bailhache, Vice-President of the Education Committee, replied as follows -

"2. In March of this year, the Education Committee, in accordance with the constitution of the Arts Trust, received representations from the Arts Trust for changes to its constitution. The Committee gave its approval, in principle, to the proposals on the understanding that the Trust would take further advice and return to the Committee, in due course, with a detailed draft of the amendments prior to representations to the Royal Court.

The Arts Trust is engaged in further discussions with interested groups. Members are well aware of the extent and nature of those discussions. Because of the difficulties which have been experienced, the consultative

process now includes arrangements for conciliation and we are most appreciative of the commitment that is being given by Jurat Nick Herbert who is chairing a first meeting of interested parties on Tuesday, 21st October 1997.

I must stress to members that the proposals for amendments to the constitution of the Arts Trust are still `on the table'. Furthermore, I am not a member of the group which will be meeting with Jurat Herbert and I am sure that members will agree that it would be quite inappropriate for me to make any statement which might influence or prejudice the conciliation which is underway."

Elysée Estate, St. Helier - Phase II: approval of drawings

- (b) to agree that a referendum shall be held when a petition containing the wording of the proposed ballot and 5,000 signatures is presented to the States;
- (c) that the procedure for calling a referendum through popular initiative should be -
 - (i) a written request for a referendum shall be submitted to the Greffier of the States; the request shall contain the text of the proposed ballot and be signed by ten voters;
 - (ii) the wording of the proposed ballot and petition shall be tested by the Greffier of the States to ensure that the intention of the motion is clear and the petition is in order. When satisfied he shall refer the matter to the Attorney General who will test the proposition for compatibility with the Island's obligations under international agreements and the Island's constitutional relationship with the United Kingdom;
 - (iii) when the above requirements have been satisfied the Bailiff shall notify the States and from that date the petitioners shall have a period not exceeding six months to gather the requisite number of signatures;
 - (iv) when the petition is complete the petitioners shall approach a willing member of the States who will present the petition to the House:
 - (v) the referendum shall be held as soon as is practically possible after that date.
