- (d) to request the Chief Minister to consult widely on the design of the proposed Public Services Ombudsman scheme, including with the members of the Jersey Complaints Board, which was established by the Administrative Decisions (Review) (Jersey) Law 1982, in order that the best elements of the Complaints Panel scheme were retained within the new system;
- (e) subject to the findings of the research set out in paragraph (c), to request the Chief Minister to bring forward primary legislation to establish the office of a Public Services Ombudsman, to replace the States of Jersey Complaints Board, as soon as was practicable, and to agree that the primary Law would include provisions for the detail and scope of the Ombudsman arrangements to be set out in Regulations and, where appropriate, Order-making powers;
- (f) subject to the findings of the research set out in paragraph (c), to request the Chief Minister to establish, and appoint with the concurrence of the Jersey Appointments Commission, a minimum of 3 suitably qualified individuals to act as a Shadow Board to oversee and drive the tasks set out in the proposition and, as soon as was practicable, for this Board to assume the role of a Shadow Public Services Ombudsman;
- (g) to request relevant Ministers to ensure that there was good co-ordination between the work of the newly-appointed Children's Commissioner and the proposed Public Services Ombudsman;
