### **Carbon Neutral Strategy and Sustainable Transport Policy – Additional Considerations for Implementation P.132/2020**

- disincentivise non-commercial and non-essential car travel;
  - disincentivise the ownership of several cars within a single household;
  - incentivise the use of public transport and non-motorised travel;
  - incentivise one-car/no-car ownership per household; and

agreed that this would be undertaken whilst maintaining the fifth principle of the C.N.S. that the overall impact of carbon neutrality would not impact income inequality;
