Explanatory Note regarding subordinate legislation tabled at this meeting.

R & O 189/2001

The purpose of this Order is to increase the airport arrival security charge from £1.99 a passenger to £2.45 a passenger and to abolish the exemption from this charge that previously applied in respect of passengers arriving from other Channel Islands.

The Order was made on 12th December 2001 and comes into force on 1st January 2002.

R & O 190/2001

This Amendment revises harbour dues for arriving and departing passengers, imported and exported goods and mail, and vehicles carried on "drive on/drive off" ferries. Generally, the dues are increased by 2.5 per cent.

The Amendment was made on 12th December 2001 and comes into force on 1st January 2002.

R & O 191/2001

This Amendment increases dues that are payable for moorings (other than those for visiting yachts) by 3.9 per cent.
