**Explanatory Note regarding subordinate legislation

**R & O 25/2001**

This Order grants an exemption from the requirement to register under the Financial Services (Jersey) Law 1998 to certain persons when carrying on trust company business of a type specified in the Order.

The Order was made on 29th January 2001 and came into force forthwith.

**R & O 26/2001**

This Order grants exemptions from the requirement to register under the Financial Services (Jersey) Law 1998 to certain persons when carrying on trust company business of a type specified in the Order.

The Order was made on 29th January 2001 and came into force forthwith.

**R & O 27/2001**

The effect of this Order is to allow the Jersey Kart and Motor Club to close the Ronez road loop in St. John, between 9.30 a.m. and 2.30 p.m. on each of the Sundays specified in the Schedule to the Order, for the purpose of holding motor races with karts.
