## **Explanatory Note regarding subordinate legislation tabled at this meeting.**

### **R&O 84/2002**

The purpose of this Order is to prescribe the fees to be paid on the application for and the issue or amendment of fire certificates.

The Order was made on 5th September 2002 and came into force forthwith.

### **R & O 85/2002**

The purpose of this Order is to reduce the length of restriction to traffic in one direction on La Rue du Moulin de Ponterrin.

The Order was made on 9th September 2002 and comes into force on 24th September 2002.

### **R & O 86/2002**

The purpose of this Order is to prohibit parking for a period exceeding 12 hours in any continuous period of 24 hours on Le Chemin des Piétons and part of La Neuve Route in St. Brelade.

The Order was made on 9th September 2002 and comes into force on 1st October 2002.
