**NOTIFICATION OF STANDING ORDER DECISIONS -
FINANCE AND ECONOMICS COMMITTEE
(delegated functions)**

3rd December 2004

- (a) as recommended by the Environment and Public Services Committee, the lease to Silverwood Business Park Limited of the ground and first floor office accommodation at Broadcasting House, Rouge Bouillon, St. Helier (together with 6 associated car parking spaces), for a period of 13 months from 1st December 2004, at an annual rent of £23,000 payable monthly in advance, with no provision for a rent review, on the basis that the ingoing tenant would be responsible for meeting the service charge payments in respect of the communal facilities and charges associated with the building, and also for meeting the landlord's fees in respect of the preparation of the lease in an amount of £200; and,

- (b) as recommended by the Housing Committee, the lease to Mr. Nicholas Paul Hougardy and Mrs. Niamh Veronica Hougardy, née Hayes, of a strip of land (measuring 92.5 square metres) located adjacent to the southern boundary of the property known as Tarawera, Le Mont Cochon, St. Helier, to be used for the purpose of a private garden, for a period of nine years from 1st October 2004, at an annual rent of £200 payable annually in advance to be reviewed annually in line with the Jersey Retail Price Index, on the basis that the Lessee would effect and maintain Public Liability Insurance cover for a sum of not less than £2 million and would be responsible for the public's legal fees up to a cost of £250.
