Explanatory Note regarding subordinate legislation tabled at this meeting.

R&O 135/2004.

The effect of this Order is to impose on a permanent basis the following one-way traffic requirements in Halkett Place –

- (a) between Beresford Street and Burrard Street, in the direction from Beresford Street towards Burrard Street ; and
- (b) between Beresford Street and Hill Street, in the direction from Beresford Street towards Hill Street.

These replace temporary requirements which have now expired.

The present Order was made by the Environment and Public Services Committee on 18th November 2004, after consultation with the Connétable of Saint Helier, and comes into force on 19th November 2004.
