# Explanatory Note regarding subordinate legislation tabled at this meeting.

(See Item B)

#### R&O.146/2006

This Order gives effect to the 5 codes of practice set out in the Schedules to the Order.

The Order was made on 6th December 2006 and comes into force on the same day as the Regulation of Investigatory Powers (Jersey) Law 2005.

#### R&O.147/2006

This Order authorizes certain interceptions of telecommunications which would otherwise be prohibited by the Regulation of Investigatory Powers (Jersey) Law 2005.

The interception must be by or with the consent of a person carrying on a business. For this purpose, administrations of the States, public authorities and others exercising functions conferred by enactments are taken to be carrying on a business.

The interception must be for purposes relevant to the business, and using the business's own telecommunications system.

Interceptions are authorized for -

- (a) monitoring or recording communications
  - to establish the existence of facts, to ascertain compliance with regulatory or self-regulatory practices or procedures or to ascertain or demonstrate standards which are or ought to be achieved (quality control and training) (NOTE: in this case the authorization is limited to what would be permitted in a Member State by virtue of Article 5 of Council Directive 2002/58);
  - in the interest of national security (in this case, only where the interception is made by or on behalf of the police or another law enforcement or intelligence agency specified in the principal Law);
  - to prevent or detect crime;
  - to investigate or detect unauthorized use of telecommunications systems; or
  - in order to secure or as an inherent part of the effective operation of the telecommunications system;
- (b) monitoring received communications to determine whether they are business or personal communications; or
- (c) monitoring communications made to anonymous telephone helplines.

Interception is only authorized if the controller of the telecommunications system on which they are made has made all reasonable efforts to inform potential users that interceptions may be made.

Article 5 of Council Directive 2002/58 says -

## "Confidentiality of the communications

1. Member States shall ensure the confidentiality of communications and the related traffic data by means of a public communications network and publicly available electronic communications services, through national legislation. In particular, they shall prohibit listening, tapping, storage or other kinds of interception or surveillance of communications and the related traffic data by persons other than users, without the consent of the users concerned, except when legally authorised to do so in accordance with Article 15(1). This paragraph shall not prevent technical storage which is necessary for the conveyance of a communication without prejudice to the principle of confidentiality.

- 2. Paragraph 1 shall not affect any legally authorised recording of communications and the related traffic data when carried out in the course of lawful business practice for the purpose of providing evidence of a commercial transaction or of any other business communication.
- 3. Member States shall ensure that the use of electronic communications networks to store information or to gain access to information stored in the terminal equipment of a subscriber or user is only allowed on condition that the subscriber or user concerned is provided with clear and comprehensive information in accordance with Directive 95/46/EC, inter alia about the purposes of the processing, and is offered the right to refuse such processing by the data controller. This shall not prevent any technical storage or access for the sole purpose of carrying out or facilitating the transmission of a communication over an electronic communications network, or as strictly necessary in order to provide an information society service explicitly requested by the subscriber or user."

The Order was made on 6th December 2006 and comes into force on the same day as the Regulation of Investigatory Powers (Jersey) Law 2005.

#### R&O.148/2006

This Order contains miscellaneous provisions supplemental to the operation of the Regulation of Investigatory Powers (Jersey) Law 2005.

*Article 1* is the interpretation provision.

Article 2 specifies information that must be included in the records kept relating to covert human intelligence sources.

Article 3 restricts the use of a covert human intelligence source who is under the age of 16.

Article 4 requires that, if a covert human intelligence source is under the age of 16, an appropriate adult (for example, a parent or guardian) must be present at any meeting between the source and the investigating authority.

Article 5 requires that, where it is proposed to use a covert human intelligence source who is under the age of 18, the use of the source cannot be authorized without the risk of physical injury or psychological distress to the source being assessed. If there are such risks, they must be justified and explained to the source.

Article 6 provides that an authorization to use a covert human intelligence source who is under the age of 18 cannot have effect for more than one month, although it can be renewed.

Article 7 specifies who must exercise any duty to cancel an authorization in the event that the person who would otherwise be subject to that duty is no longer available to exercise it.

Article 8 specifies circumstances in which a person who has power to grant an authorization may delegate that power.

Article 9 provides for the Order to come into force as the same day as the Law.

The Order was made on 6th December 2006.

#### R&O.149/2006

This Order increases by 2.4% the fishing boat licence fee (a fee that was last increased early in 2006) and by 5% and 3% the scallop permit fees (fees that were last increased at the end of 1999).

The Order was made on 7th December 2006 and came into force on 1st January 2007.

# R&O.150/2006

This Order updates a reference to legislation that has been replaced.

The Order was made on 6th December 2006 and came into force 7 days after it was made.

# R&O.151/2006

The purpose of this Order is –

- (a) to narrow (to most cattle) the class of animals to which the Contagious Abortion (Jersey) Order 1958 is expressed to apply, because contagious abortion (now more commonly known as bovine brucellosis or by the name of the pathogen responsible *Brucella abortus*) does not normally affect sheep, goats or pigs, and only rarely affects horses;
- (b) to give temporal precision to the meaning, for certain purposes, of abortion in that Order;
- (c) to make it clear that, when a cow is deemed to be affected with bovine brucellosis because it has suffered an abortion or premature calving, a notice from an inspector may end that deeming in appropriate cases;
- (d) to make it clear that when a cow suffers an abortion or premature calving, the person in charge must keep the calf or foetus, and other matter, until notified otherwise by an inspector;
- (e) to allow the Minister to use discretion in deciding whether to have animals examined in certain cases of bovine brucellosis or suspected bovine brucellosis.

The Order was made on 7th December 2006 and came into force on 1st January 2007.

# R&O.152/2006

This Order means that the accounts of any body that receives from the States £5,000 or more to carry out its activities may be audited by the Comptroller and Auditor General.

The Order was made on 11th December 2006 and came into force on 18th December 2006.

#### R&O.153/2006

This amendment to the Tariff of Harbour and Light Dues will –

- (a) increase, by 2.5%, the harbour dues for arriving and departing passengers and vehicles carried on 'drive on/drive off' ferries;
- (b) increase, by 3.6%, the dues payable for marina, visiting craft and other mooring spaces.

The dues were last increased 1 year ago. The Amendment was made on 13th December 2006 and came into force 1st January 2007.

#### R&O.1/2007

This Order amends the Order which sets out restrictions on the movement and parking of vehicles in St. Helier.

Article 6 sets out -

- (a) new provisions that establish a requirement that only persons with residential or business parking permits should be able to park in certain parts of the 'Stopford Road Zone' or the 'Richmond Road Zone' at certain times of day;
- (b) fees of £200 a year for a resident's parking permit in the Stopford Road Zone, £100 a year for a resident's parking permit in the Richmond Road Zone and £150 a year for a business parking permit in the Richmond Road Zone;
- (c) that a permit in relation to a vehicle may be transferred to a substitute vehicle and that a proportionate amount of the fee for the permit may be refunded if the permit is surrendered.

Article 7 prohibits motorcycles and mopeds from being parked on certain areas of road within the Zones.

Other Articles make amendments consequential to the provisions inserted by Article 6, or amend the Schedules setting out –

- (a) roads in other parts of St. Helier that are one-way traffic routes (Schedule 1);
- (b) junctions at which vehicles are required to stop (Schedule 3);
- (c) roads where waiting is prohibited (Schedule 4);
- (d) roads on which paying parking places are established (Schedule 8);
- (e) roads where parking for the purpose of loading or unloading vehicles is restricted (Schedule 10); and
- (f) where motorcycles and mopeds may, or may not, be parked (Schedule 11).

The Order shall come into force 14 days after it is made.

The Order was made on 5th January 2007.

#### R&O.2/2007

This Order corrects a reference to "Committee" to read "Minister" in the Road Traffic (Disabled Persons) (Parking) (Jersey) Order 2002 and further amends that Order to make changes to the disabled parking places provided on roads in St Helier.

The Order was made on 5th January 2007 and comes into force on 12th January 2007.

The Minister for Planning and Environment will table an answer to the following question asked by Deputy K.C. Lewis of St. Saviour –

"Further to public concerns, would the Minister undertake to ensure that no mobile telephone masts and base units are sited less than 300 metres from any school or medical facility?"

The Minister for Planning and Environment will table an answer to the following question asked by Deputy K.C. Lewis of St. Saviour –

"Following the recent tragedy in the United Kingdom involving a pit bull terrier, is the Minister confident that the current law in Jersey regarding dangerous breeds of dogs is adequate and, if not, what plans, if any, does he have to tighten controls?"

The Minister for Housing will table an answer to the following questions asked by Deputy G.P. Southern of St. Helier –

- "(a) On page 43 of the report "Planning for Homes 2006" (R.94/2006) it states that one of the contributing factors to the rise in activity (and prices) in the housing market identified by estate agents is "new 'j category' (essential employee) buyers". How does the Minister reconcile this with his written answer on 5th December 2006 in which he stated that "it is simply not plausible (...) to ascribe the increase in house prices to a small number of essential employees"?
- (b) In light of the statement in the Planning for Homes 2006 report that the average prices for certain 3 bedroom houses are now "more than ten times current average annual earnings" what action, if any, does the Minister intend to take to tackle this situation in a meaningful way?
- (c) Would the Minister inform members whether the purchase of property by non-residents on a "buy to let" basis further restricts the supply of properties for purchase by locals and whether such purchases put additional upward pressure on prices?"

The Chief Minister will table an answer to the following question asked by Deputy G.P. Southern of St. Helier-

"Would the Chief Minister inform members what progress, if any, has been made towards co-ordination between the Population Office, the Health and Social Services Department, the Social Security Department and the Data Protection Commissioner over the Population Register?"

The Minister for Social Security will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"(a) Would the Minister agree to seek an explanation from the Employment Forum for its decision to base the 2007 minimum wage recommendation on the figure of 40% of the average wage and inform members of it and, in particular, would the Minister seek an explanation of why the recommendation is not referenced to the internationally accepted relative low income threshold of 60% of median income?

- (b) Would the Minister inform members of Jersey's current relative low income threshold for a 40-hour week, and state how the minimum wage recommendation relates to this weekly figure?
- (c) In the light of this information, what steps, if any, will the Minister take to lift the family types given in Table 13 of the 2002 Income Distribution Survey (appropriately updated) on the minimum wage out of relative poverty? In particular, will he consider raising the minimum wage above the recommendation?
- (d) Does the Minister support the Employment Forum's recommendation to introduce a "Youth Rate" at £4.05 for employees aged 16 to 18 in full-time education? Is the Minister aware of any such employees (in Saturday/holiday jobs) who are currently paid at a lower rate?

# **Question 2**

Has the Minister received the final draft of the report he commissioned into the working of Long-Term Incapacity Allowance (LTIA) yet and, if so, will he –

- (a) inform members what the report has to say concerning the long-term impact of LTIA for non-contributory funding?
- (b) agree to release the full report to members?

If he has not yet received this report when does he expect to do so?

# **Question 3**

In a written answer tabled on 5th December 2006 the Minister suggested that increases in supplementation in 2006 appeared "to be as a result of growth and change in employment rates at the lower to middle-income earning levels." Would the Minister inform members what progress, if any, has been made in investigating this increased demand on tax revenues?

#### **Ouestion 4**

- (a) Would the Minister detail for members whether consultation was undertaken with the Data Protection Commissioner over the questions asked in the application forms IS.01R and IS.01T relating to Income Support?
- (b) How many households have been asked to complete these application forms and how were they chosen?
- (c) Can the minister explain why a 27-page questionnaire of such complexity for benefit claimants is necessary and, in particular, justify, on data protection grounds or otherwise, why the following information is being requested
  - (i) details of any assets over the value of £1,000 held by the claimant or anyone in the household (section H, p.17).
  - (ii) the current value of any land or property and income received by any other household member (section H, p18).
  - (iii) details of -
    - (1) benefits in kind;
    - (2) social security contributions;

- (3) ITIS percentage;
- (4) contributory pension payments? (section G page 14)
- (iv) Three-month bank statements from the claimant and other members of the household.
- (v) Details of income from benefits from therapeutic working and other benefits that hitherto have been disregarded for rent rebate or other purposes?
- (d) In section K it is revealed that information may be shared by up to eight departments or other parties. What safeguards, if any, are, or will be, put in place to ensure that data are not inappropriately shared? Will the Population Office be added to the list of those departments that can share the data and, if not, is the population register to be kept entirely separate?"

The Minister for Treasury and Resources will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Would the Minister inform members what target deadlines, if any, were set for the production of the following reports on the potential sell-off of Jersey Telecom and state whether any targets set have been met? If not, has this had any impact on the proposed schedule for action on this matter?

- (a) Citigroup;
- (b) Jersey Competition Regulatory Authority;
- (c) Economic Advisor."
