## **Explanatory Note regarding subordinate legislation tabled at this meeting.**

### **R&O.108/2010.**

This Order applies a 30mph speed limit to 2 parts of La Grande Route de St. Clement, one of which is from its western end to a point near La Rue du Hocq. The Road Traffic (Speed Limits) (Amendment No. 5) (Jersey) Order 2010 would instead have applied the limit from the point near La Rue du Hocq eastwards to La Verte Rue. This Order comes into force immediately after the coming into force of the previous amendment in order to correct its effect on this road.

The Order was made on 11th November 2010 and came into force on 12th November 2010.

### **R&O.109/2010.**

This Order amends the Road Traffic (St. Ouen) (Jersey) Order 1979. It prohibits waiting on part of the east and the whole of the west of La Rue des Cosnets, and on part of the east of La Rue des Marettes. It also prohibits driving vehicles wider than 6 feet 6 inches on La Verte Rue (Cueillette de Millais) and part of Le Mont Matthieu.

The Order was made on 11th November 2010 and comes into force on 25th November 2010.
