2. Deputy J.A. Martin of St. Helier will ask the following question of the Minister for Economic Development –

"What consideration, if any, has been given in relation to licenced premises and opening hours during this year's World Cup?"

3. Deputy N.B. Le Cornu of St. Helier will ask the following question of the Minister for Social Security –

"Will the Minister advise what safeguards, if any, are in place for employees who are unfairly dismissed prior to completing 6 months of employment?"

4. Deputy S.S.P.A. Power of St. Brelade will ask the following question of the Chairman of the Comité des Connétable –

"Could the Chairman outline to the Assembly the criteria under which any member of the Honorary Police could be served with a long service medal for diligent service to the Parish and community, particularly in light of their recent involvement in various high profile incidents and could he inform the Assembly if and when long service medals might ever be awarded?"

5. The Deputy of St. Mary will ask the following question of the Minister for Treasury and Resources –

"Given that there are a lot of properties throughout the Island that not on mains water and are therefore reliant on bore wells and springs for drinking water and in view of the risks of the water table being polluted by slurry spreading and domestic soak-aways, would the Minister consider funding the cost of water tests by the States Analyst for residents of these properties?"

6. Deputy J.H. Young of St. Brelade will ask the following question of the Minister for Planning and Environment –

"Will the Minister inform the Assembly of the costs incurred by his Department and the Law Officers' Department in defending Planning Appeals since his appointment and the number of cases and costs incurred where he has initiated appeals against a Royal Court judgment made against him and advise how he justifies spending public money to ensure, via costs imposed on appellants, he has the final say in such decisions?"



7. Deputy J.A. Hilton of St. Helier will ask the following question of the Minister for Health and Social Services –

"What action, if any, is the Minister taking to reduce the 9 month long waiting time for those seeking adult psychological services?"

8. Deputy G.P. Southern of St. Helier will ask the following question of the Chief Minister –

"In granting permission for them to trade under the Control of Housing and Work Law, will the Chief Minister state what investigations, if any, were made into the role that Henderson Infrastructure, a Jersey company played in financing the construction and servicing of Alder Hey hospital, Liverpool, through Laing O'Rourke plc and Alder Hey (Special Purpose Vehicle) Ltd and whether such activity enhances the reputation of the Island's finance sector?"

9. The Connétable of St. John will ask the following question of the Chairman of the Privileges and Procedures Committee –

"Could the Chairman confirm whether the new provisions relating to IT expenses for States Members will result in £31,000 of tax payers' money being spent annually on IT equipment for members?"

10. Deputy M. Tadier of St. Brelade will ask the following question of the H.M. Attorney General –

"Will H.M. Attorney General clarify whether the importation and possession of cannabis for medicinal use would be possible under the provisions of the Misuse of Drugs (Jersey) Law 1978 and, in particular, whether the Minister for Health and Social Services has the power to issue a licence allowing possession of cannabis for medicinal use?"

11. Deputy G.C.L. Baudains of St. Clement will ask the following question of the Chairman of the Jersey Branch of the Commonwealth Parliamentary Association –

"Which members have been selected to attend the annual Commonwealth Parliamentary Association conference in October 2014 and what were the criteria for selection?"

12. Deputy S.S.P.A. Power of St. Brelade will ask the following question of the Minister for Economic Development –

"Can the Minister advise whether some companies involved predominantly in RO-RO freight shipment to the Channel Islands are quoting unsustainable freight rates and, if so, is he concerned that these low rates have the potential to damage the viability of shipping to the Channel Islands?"

13. Deputy M. Tadier of St. Brelade will ask the following question of the Chairman of the Health and Social Services Scrutiny Panel –

"Will the Chairman advise if the Panel has reviewed or intends to review the Minister's proposed action to address clinical waiting times, including those for mental health related issues?"

"Given that when the States approved the Sustainable Transport Policy in December 2010, members voted unanimously to request the publication within a year of a target for road accident reduction and the rationale behind it and also comprehensive strategies designed to facilitate and encourage walking and cycling, could the Minister explain the delay in carrying out the wishes of the States and update members on progress?"

"Will the Minister gives assurances that there are no adverse effects on activity between the Channel Islands, whether for business, cultural, sporting, tourism or private family purposes, as a consequence of the significant reduction in inter-island flights following the withdrawal of services to Guernsey by Aurigny and advise what action, if any, he will take to maintain services to an adequate level to properly serve our two communities?"

## Explanatory Note regarding subordinate legislation tabled at this meeting.

(See Item B)

#### R&O.31/2014.

This Order amends, in the Income Support (General Provisions) (Jersey) Order 2008, the capital and income to be disregarded when calculating a household's income for the purposes of income support.

Two changes are made to the capital disregards.

- If, on the death of an adult, a household becomes a household containing a sole adult, the capital disregard that applied to the household prior to the death shall continue to apply for the 12 months following the death.
- The capital disregard of up to £10,000 for a motor vehicle is replaced with a disregard that has no monetary limit, but is assessed according to whether a vehicle is, or vehicles are, appropriate to the needs of the household.

The percentage disregard for total earnings is increased from 20% to 23%.

The Order was made on 28th March 2014 and comes into force on 7th April 2014.

#### R&O.32/2014.

This Order contains miscellaneous amendments to Orders made under a number of Laws dealing with financial regulation.

Article 1 amends the Banking Business (Appointment of Manager) (Jersey) Order 2008 in order to widen the list of breaches of laws and codes that are regarded as evidence that the management of a business has been inadequate. Such evidence may allow the Jersey Financial Services Commission to act under Article 37A of the Banking Business (Jersey) Law 1991 by appointing a person to manage the affairs of the business.

Article 2 amends the Collective Investment Funds (Appointment of Manager) (Jersey) Order 2008 for an analogous purpose.

Article 3 amends the Financial Services (Appointment of Manager) (Jersey) Order 2008 for an analogous purpose.

Article 4 amends the Financial Services (Financial Service Business) (Jersey) Order 2009 in order to insert a definition of the term "Law" as meaning the Financial Services (Jersey) Law 1998.

Article 5 amends the Insurance Business (Solvency Margin) (Jersey) Order 1996. The latter Order requires certain insurers to maintain a margin of solvency for general business of 17.5% of net premium income. The purpose of the amendment is to make it clear that in order to determine the amount of net premium income, one deduction that must be made from the gross premium income is an amount corresponding to the premiums paid on reinsurance, not the actual amount subject to reinsurance.

Article 6 amends the Insurance Business (Appointment of Manager) (Jersey) Order 2008 for a purpose analogous to that of the amendments set out in Articles 1, 2 and 3.

Article 7 names the Order and provides for it to come into force 7 days after it is made.

The Order was made on 28th March 2014 and comes into force on 4th April 2014.

#### R&O.33/2014.

This Order amends the Schedules to the Road Traffic (Speed Limits) (Jersey) Order 2003, as follows –

Schedule 1 is amended so as to impose a 30 mph speed limit on certain roads and parts of roads in the parishes of St. Brelade, St. John, St. Mary, St. Peter and Trinity;

Schedule 2 is amended so as to impose a 20 mph speed limit on certain roads and parts of roads in the parishes of St. Brelade, Grouville, St. Helier, St. Mary, St. Peter and St. Saviour;



Schedule 3 is amended so as to impose a 15 mph speed limit on certain roads and parts of roads in the parish of St. Mary, and to clarify that in the parish of St. Peter, 2 roads and the unnamed roads that branch from them are subject to a 15mph speed limit.

This Order comes into force 7 days after it is made.

The Order was made on 28th March 2014 and comes into force on 4th April 2014.
