R&O.66/2021.

Road Traffic (Miscellaneous Amendments – Coastguard Vehicles) (Jersey) Order 2021. *Minister for Infrastructure*.

This Order amends 3 Orders under the Road Traffic (Jersey) Law 1956 (the "Law") so that various requirements under that Law, including the requirement to comply with traffic lights, do not apply to vehicles used for emergency purposes by the Jersey Coastguard service. (Such vehicles are referred to in this note as "Coastguard vehicles"). The provisions are similar to those that already exist for vehicles used by ambulance, fire and rescue and police services.

Article 1 amends the Motor Vehicles (Construction and Use) (Jersey) Order 1998 so that the requirement in that Order which prohibits motor vehicles from being fitted with a bell, gong, siren or 2-tone horn does not apply to Coastguard vehicles.

Article 2 amends the Road Traffic (Lighting) (Jersey) Order 1998 so that Coastguard service vehicles are included in the definition of "emergency vehicles". The effect of the amendment is that, as an "emergency vehicle" blue flashing lights can be fitted to a Coastguard vehicle.

Article 3 amends the Traffic Signs (Jersey) Order 1968 so that, provided certain conditions in the Law are met, drivers of Coastguard vehicles are not guilty of offences under the Law for failing to comply with traffic lights and traffic signs prescribed in that Order.

Article 4 sets out the title of this Order and provides for it to come into force 7 days after the day it is made. The Order was made on 10th May 2021 and came into force on 17th May 2021.

R&O.67/2021.

Motor Traffic (Cabs – General) (Jersey) Order 2021.

Minister for Infrastructure.

This Order repeals the Motor Traffic (Taxi-Cabs – General) (Jersey) Order 2002 ("2002 Order") and replaces it with conditions of use which remove the current distinction between private-hire cabs and taxis. There are no longer different conditions of use depending on whether the public service licence in force in respect of a vehicle restricts the use of taxi ranks (currently the case with private-hire vehicles) or allows taxi ranks to be used without restriction (currently the case with taxis). Limousines providing cab services are unaffected.

Article 1 is an interpretation provision. The Motor Traffic (Jersey) Law 1935 defines "cab" to mean "a motor vehicle providing a cab service". "Cab service" is defined in that Law as "a service that consists of the carriage by motor vehicles of passengers for hire or reward under a contract expressed or implied for the use of the vehicle as a whole at a fixed rate or for an agreed sum.". "Taxi-cabs" are defined in this Order to mean all cabs which have a public service licence that permits them to use taxi ranks. "Limousine-cabs" are defined in this Order to mean all cabs which have a public service licence that does not permit them to use taxi ranks. In this Order, "cab" means a "limousine-cab" or a "taxi-cab": there are no other categories of "cab".

Article 2 prohibits any vehicle that is not a taxi-cab from stopping, waiting, or picking up passengers at a taxi rank.

Articles 3 to 8 prohibit a taxi-cab from being used to provide a cab service unless –

- it has a sign showing that it is a taxi-cab and whether it is available for hire;
- its public service licence number is displayed;
- its fares and charges are displayed;



- it is fitted with a properly operating taxi meter for calculating fares and charges;
- it is fitted with a properly operating device for electronic payments; a notice is displayed indicating that electronic payments may be made.

Article 9 sets out conditions of use for limousine-cabs relating to payment and signs.

Article 10 prohibits a passenger in a cab from behaving in various disorderly or distracting ways.

Article 11 sets out criminal offences for breach of the various prohibitions in this Order. The maximum penalty is a fine of level 2 on the standard scale, that is £1,000.

Article 12 is a transitional provision which is triggered by the date that the Motor Traffic (Public Service Vehicles (Conditions of Fitness)) (Amendment No. 3) (Jersey) Order 2021 ("amending Order") comes into force, that is, on 31st May 2021. The amending Order sets out "accessibility requirements" with which taxi-cabs must comply in order for a certificate of fitness to be issued. The accessibility provisions re-enact, with modifications and subject to a phasing-in period, provisions that are equivalent to Articles 26 to 30 and 31 of the Motor Traffic (Public Service Vehicles (Conditions of Fitness)) (Jersey) Order 2003 (the "2003 Order") as in force before 31st May 2021. The requirements relate to specified features, such as swivel cushions and door threshold strips.

With respect to taxis, *Article 12* allows taxis to continue to use taxi ranks and pick up passengers under Article 2 of the 2002 Order until the date (the "specified date") that the taxi must meet the accessibility requirements under the 2003 Order after 31st May 2021.

If the existing licence expires on or after 1st December 2021, the specified date under the 2003 Order is the date that the existing licence expires. If the existing licence expires between 31st May 2021 and 30th November 2021 inclusive and the taxi does not comply with the accessibility requirements on the date of expiry, the specified date is 6 months after the date a new licence is granted provided that date is on or before 31st May 2022.

Once the specified date is reached and a taxi complies with the accessibility requirements, a public service licence that is granted in respect of the taxi will allow it to access taxi ranks without restriction and the need for Article 2 of the 2002 Order will fall away.

With respect to private-hire cabs that do not meet the accessibility requirements, *Article 12* continues the restrictions regarding access to taxi ranks under the 2002 Order. Such restrictions continue until the date the private hire cab complies with the accessibility requirements.

Article 13 repeals the 2002 Order.

Article 14 sets out the title of this Order and provides for it to come into force on 31st May 2021.

The Order was made on 10th May 2021 and came into force on 31st May 2021.

R&O.68/2021.

Motor Traffic (Public Service Vehicles (Conditions of Fitness)) (Amendment No. 3) (Jersey) Order 2021. *Minister for Infrastructure*.

This Order amends the Motor Traffic (Public Service Vehicles (Conditions of Fitness)) (Jersey) Order 2003 (the "2003 Order") so as to require all cabs, apart from limousine taxi-cabs, to be compliant with conditions so that they can be used by persons with a disability.

Article 1 is an interpretation provision enabling this Order to be construed as amending the 2003 Order.

Article 2 inserts definitions relating to different kinds of cab. The Motor Traffic (Jersey) Law 1935 defines "cab" to mean "a motor vehicle providing a cab service". "Cab service" is defined in that Law as "a service that consists of the carriage by motor vehicles of passengers for hire or reward under a contract expressed or implied for the use of the vehicle as a whole at a fixed rate or for an agreed sum.". This Order also defines a "limousine taxi-cab" to mean a motor vehicle providing a cab service which excludes picking up passengers at a taxi rank. "Taxi-cab" is defined in this Order to mean a motor vehicle providing a cab service that includes picking up passengers at a taxi rank. "Taxi rank" is also defined in this Order to mean a stand established by the Minister under the Motor Traffic (Jersey) Law 1935.



Article 3 substitutes Part 2A of the 2003 Order setting out the conditions of fitness for cabs and Article 4 inserts a new Schedule.

The requirements in the new Part 2A relate to seats, signs, markings, meters and accessibility requirements. With the exception of a requirement relating to seats, supports and maximum passenger number signs, the requirements apply to taxi-cabs but not to limousine-cabs. Part 2A also requires all taxi-cabs to comply with accessibility requirements set out in Part 1 of the new Schedule inserted by *Article 4*. Part 2 of the Schedule sets out requirements with which taxi-cabs must comply if the taxi-cab can accommodate at least one person seated in a wheelchair. Limousine taxi-cabs are not required to comply with the requirements in the Schedule.

The new Part 2A also includes a transitional provision. It applies to private-hire cabs and taxis within the meaning of the Motor Traffic (Taxi-Cabs – General) (Jersey) Order 2002 ("2002 Order") in respect of which (a) a public service licence ("existing licence") is in force on 30th May 2021; and (b) on 31st May 2021, the requirements of Part 1 of the Schedule are not met.

For those vehicles, the 2003 Order continues to apply as if this amending Order were not in force until the existing licence is no longer in force. However, if the existing licence expires on or before 30th November 2021 and the taxi or private-hire cab does not comply with Part 1 of the Schedule on the expiry date, one certificate of fitness may be granted as if this amending Order were not in force provided the certificate lasts for 6 months only and expires on or before 31st May 2022. Under Article 10(2) of the Motor Traffic (Jersey) Law 1935, a public service licence of a vehicle is suspended during any period when a certificate of fitness is not in force in respect of it. This means that when the 6 month certificate of fitness expires, a taxi or private-hire cab will not be able to resume providing cab services under the public service licence until the requirements of Part 1 of Schedule 1 are met and a new certificate of fitness is granted.

A further transitional provision is made in respect of taxis or private-hire cabs which, on 31st May 2021, do not meet the requirements in Part 1 of the Schedule relating to airbags when a vehicle is transporting an assistance dog or to storage space for wheelchairs and mobility scooters. Those requirements do not apply to such a vehicle until the holder of the public service licence for the vehicle submits a different vehicle for examination for use as a taxi-cab.

Article 5 sets out the title of this Order and provides for it to come into force on 31st May 2021.

The Order was made on 10th May 2021 and came into force on 31st May 2021.

R&O.69/2021.

Immigration (Fees) (Amendment No. 6) (Jersey) Order 2021.

Assistant Minister Deputy G.C.U. Guida of St. Lawrence for and on behalf of the Minister for Home Affairs.

The Immigration (Fees) (Amendment No. 6) (Jersey) Order 2021 inserts 2 new definitions into Article 1 of the Immigration (Fees) (Jersey) Order 2017, and amends the table of fees in Article 2(2).

The Order amends Article 1 by inserting two definitions: "seasonal employment", being employment in the agriculture sector, hospitality sector or as crew on a fishing vessel; and "sector-based employment", being employment in the construction industry.

In the table of fees in Article 2, the Order amends paragraph (c) so that the current description of work permit by reference to "employment in an unskilled job" is replaced with the new reference to "seasonal employment".

New paragraph (ca) specifies the fee for a person whose work permit authorises sector-based employment for a period not exceeding one year and which may be extended.

New paragraph (cb) specifies the fee for a person whose work permit under (ca) is extended so that the total period of work exceeds one year.

New paragraph (cc) specifies the fee for a dependant of a person with a work permit that has been extended to exceed one year in total. Paragraphs (d) and (e) are amended to reflect new paragraph (cb).

The Order comes into force on the day after it is made.

The Order was made on 10th May 2021 and came into force on 11th May 2021.

Covid-19 (Workplace Restrictions) (Amendment No. 12) (Jersey) Order 2021.

Minister for Health and Social Services.

This Order amends the Covid-19 (Workplace Restrictions) (Jersey) Order 2020 to widen the purposes for which food and drink premises may be open. In the case of food and drink premises that are part of wider premises that include an auditorium or a stadium, the premises may be open for the purpose of selling food or drink (other than alcoholic drinks) to customers for consumption in the auditorium or stadium. Otherwise the food or drink must be sold to be taken outside the wider premises or to be consumed at a table in the premises.

The Order was made on 17th May 2021 and came into force on 18th May 2021.

Covid-19 (Workplace – Twenty-Third Extension) (Jersey) Order 2021.

Minister for Health and Social Services.

This Order amends the Covid-19 (Workplace Restrictions) (Jersey) Order 2020, to extend the restriction period to end at the end of Wednesday 30th June 2021.

This Order comes into force on 1st June 2021.

The Order was made on 25th May 2021 and came into force on 1st June 2021.

Covid-19 (Gathering Control – Seventh Extension) (Jersey) Order 2021.

Minister for Health and Social Services.

This Order amends the Covid-19 (Gathering Control) (Jersey) Order 2020, to extend the gathering control period to end at the end of Wednesday 30th June 2021.

This Order comes into force on 1st June 2021.

The Order was made on 25th May 2021 and came into force on 1st June 2021.

R&O.73/2021.

Mental Health (Miscellaneous Provisions and Prescribed Forms) (Amendment No. 2) (Jersey) Order 2021. *Minister for Health and Social Services*.

This Order amends Article 3 of the Mental Health (Miscellaneous Provisions and Prescribed Forms) (Jersey) Order 2018. The Order allows the Minister for Health and Social Services to attach a condition to the approval of the appointment of a registered medical practitioner ("doctor") as an approved practitioner under the Mental Health (Jersey) Law 2016 to limit it to appointment as a medical member of the Mental Health Review Tribunal, provided a certain requirement is fulfilled. Currently the requirement is that the doctor has such degree of experience or training in mental health matters as would reasonably be expected to provide him or her with enough understanding of the medical issues likely to arise before the Mental Health Review Tribunal to be an effective medical member. In future the doctor must also have completed the Mental Health (Jersey) Law 2016 Approved Practitioner Training Programme.



The Order was made on 25th May 2021 and came into force on 1st June 2021.

R&O.74/2021.

Road Traffic (St. Peter) (Amendment No. 11) (Jersey) Order 2021.

Minister for Infrastructure.

This Order amends the Road Traffic (St. Peter) (Jersey) Order 1992 with the effect of prohibiting the parking of vehicles in parts of Le Vieux Beaumont and restricting the parking of vehicles in a section of that road to a maximum of 12 hours in a period of 24 hours.

This Order comes into force 7 days after the day it is made.

The Order was made on 28th May 2021 and came into force on 4th June 2021.

R&O.75/2021.

Emergency Powers and Planning (Medicines and Vaccines – Covid-19) (Third Period) (Jersey) Order 2021.

Signed by Assistant Minister Deputy H.C. Raymond of Trinity, for and on behalf of the Minister for Health and Social Services.

This Order is a renewal of the Emergency Powers and Planning (Medicines and Vaccines – Covid-19) (Jersey) Order 2021 which relaxes controls on medicines to facilitate a plan for vaccination against Covid-19, which in turn was a renewal of the Emergency Powers and Planning (Medicines and Vaccines – Covid-19 and Influenza) (Jersey) Order 2020.

The Order expires 3 months after it comes into force (under the Emergency Powers and Planning (Jersey) Law 1990 it cannot remain in force for longer unless renewed). This Order comes into force on 5th June 2021 and will therefore expire at the end of 4th September 2021.

The Order was made on 2nd June 2021 and came into force on 5th June 2021.

- (b) whether the Study considered a combined Fire and Ambulance headquarters;
- (c) whether the Study made a comparison between the prospect of such combined headquarters and satellite substations around the Island;
- (d) whether the Study assessed the potential impact on Rouge Bouillon School, and if not, why not;
- (e) whether the Study assessed the potential impact on the surrounding neighbourhood, and if not, why not;
- (f) whether the Study assessed the potential for any increase in green infrastructure in the area, and if not, why not; and
- (g) whether the Study assessed the current levels of traffic in the area, and any potential increase should the Fire and Ambulance Headquarters be located on the site, and if not, why not?"



51. The Minister for Infrastructure tabled an answer on 8th June 2021 to the following question asked by Deputy I. Gardiner of St. Helier –

"Will the Minister advise how many feasibility studies or reviews have been undertaken since 2017 on the former States of Jersey Police Headquarters site at Rouge Bouillon, providing the following details for any such study —

- (a) the start date and completion date;
- (b) the objectives;
- (c) the department or section undertaking the study; and
- (d) the outcome;

and will he further advise whether any such studies are currently ongoing and, if so, provide the above details, where available, for any such ongoing studies?"

52. The Minister for Home Affairs tabled an answer on 8th June 2021 to the following question asked by Deputy I. Gardiner of St. Helier –

"Will the Minister advise whether it is intended to continue use of the Eastern and Western Ambulance dispatch points and the St. Brelade fire station, once a new Fire and Ambulance station is built in St. Helier?"

53. The Minister for Treasury and Resources tabled an answer on 8th June 2021 to the following question asked by Deputy K.F. Morel of St. Lawrence –

"For each of the years from 2018 to 2021, will the Minister advise how many –

- (a) invitations to tender were issued by the Government;
- (b) of these, how many were completed to the point of an organisation being chosen; and
- (c) how many were abandoned or changed such that a new process was required?"
- 54. The Minister for External Relations and Financial Services tabled an answer on 8th June 2021 to the following question asked by Deputy G.P. Southern of St. Helier –

"Further to reports that proposals from the U.S.A. for a minimum effective tax rate across international trade, whether of 15% or 21%, will be taken to the next G7 meeting, what assessment, if any, has been undertaken of the impact of implementing such proposals on Jersey's own 0/10 corporate taxation regime, in particular the operation of large-profit tech companies within this regime, and on the Island's economy?"

55. The Minister for Social Security tabled an answer on 8th June 2021 to the following question asked by Deputy G.P. Southern of St. Helier –

"In relation to Income Support payments made since the start of the Covid-19 pandemic, will the Minister inform members –

- (a) how many applicants have been in receipt of overpayment of benefits;
- (b) what the current total is of overpayments; and
- (c) what arrangements, if any, are in place for the recovery of any overpayments?"



56. The Minister for Infrastructure tabled an answer on 8th June 2021 to the following question asked by the Connétable of St. Brelade –

"Will the Minister advise members how long the car park at La Carrière quarry on the Five Mile Road is to remain closed; and what plans, if any, are in place to make the rockface safe?"

57. The Minister for the Environment tabled an answer on 8th June 2021 to the following question asked by Deputy K.F. Morel of St. Lawrence –

"When assessing whether or not to include Field MY 966 within the La Gigoulande Quarry extension safeguard zone in the draft Bridging Island Plan (B.I.P.), will the Minister advise whether he requested, or read, the results of any health impact assessments or environmental impact assessments of the effects of quarrying that field; and, if so, how were the findings then incorporated in the B.I.P.?"

58. The Minister for Economic Development, Tourism, Sport and Culture tabled an answer on 8th June 2021 to the following question asked by the Connétable of St. Martin –

"In relation to the High Value Residents scheme and the work of Locate Jersey, will the Minister outline –

- (a) what analysis, if any, is undertaken of the difference between the net income lost by not charging the standard rate of tax on such individuals' income and the estimated net benefit to the Island gained from each individual participant through this scheme;
- (b) whether such analysis is undertaken on an annual basis;
- (c) how, if at all, the information collected on each participant to the Scheme contributes to studies into the Island's past, present and predicted economic performance; and
- (d) whether there are any plans to change the way in which information on the impact of High Value Residents on Jersey's economy is publicly presented?"
- 59. The Minister for Economic Development, Tourism, Sport and Culture tabled an answer on 8th June 2021 to the following question asked by the Connétable of St. Martin –

"Will the Minister outline what research, if any, has been undertaken into the impact of the High Value Residents scheme on the average wage and the cost of living in Jersey; and also the impact, if any, that the scheme has had on the overall distribution of on-Island wealth since its introduction?"

60. The Minister for Treasury and Resources tabled an answer on 8th June 2021 to the following question asked by Deputy R.J. Ward of St. Helier –

"Following news reports that a company in Guernsey has repaid £146,000 of furlough scheme money to the States of Guernsey as the company felt it was not needed, will the Minister advise how many Jersey companies have either voluntarily repaid, or been asked to repay, money received through the Co-funded Payroll Scheme, stating in particular whether such companies include those that may have made a profit during the last year?"



61. The Minister for Home Affairs tabled an answer on 8th June 2021 to the following question asked by Deputy R.J. Ward of St. Helier –

"Will the Minister advise how many emergency ambulance call-outs have been staffed or driven by fire officers (including due to staff shortages) in the last 2 years; and how many times the ambulance service has operated at capacity so far this year in terms of its ability to respond to call-outs?"

62. The Minister for Economic Development, Tourism, Sport and Culture tabled an answer on 8th June 2021 to the following question asked by Deputy R.J. Ward of St. Helier –

"Will the Minister advise what progress, if any, has been made in developing a productivity strategy, particularly for industries such as agriculture and hospitality; and does he plan for such a productivity strategy to be developed before the outcome of the living wage review?"

63. The Minister for Treasury and Resources tabled an answer on 8th June 2021 to the following question asked by Deputy K.F. Morel of St. Lawrence –

"Of the £50 million made available through fiscal stimulus funding, will the Minister advise what amount it is estimated has been (or will be) paid to women, and how much to men, as the direct, primary recipients of any funds provided?"

64. The Minister for Home Affairs tabled an answer on 8th June 2021 to the following question asked by Deputy M.R. Higgins of St. Helier –

"Will the Minister provide –

- (a) a table showing the number of children stopped and searched by States of Jersey Police Officers over the last 5 years, with the figures broken down into those aged between 10 to 15 and 16 to 18, stating in each case the reasons for the stop-and-search and whether the individual was arrested, given words of advice or referred for prosecution; and
- (b) details of any requirements for the use of body worn cameras when conducting such stop-and-searches?"
- 65. The Minister for Children and Education tabled an answer on 8th June 2021 to the following question asked by Deputy M.R. Higgins of St. Helier –

"Will the Minister provide tables detailing –

- (a) the number of children taught in each school for each of the last 5 years whose first language was not English, as well as the number and cost of any additional teaching staff employed to carry out dedicated tuition for these children, together with any costs associated with addressing this educational need; and
- (b) the number of children taught in each school for each of the last 5 years who had a special educational need, with the figures broken down by need (i.e. physical, autism spectrum disorders, dyslexia, reading difficulties, behavioural), as well as the costs of supporting the children with these needs?"



66. The Minister for Children and Education tabled an answer on 8th June 2021 to the following question asked by Deputy M.R. Higgins of St. Helier –

"Will the Minister –

- (a) provide a table showing, for each of the last 5 years, the year-end finances for each school, including the respective surplus and deficit;
- (b) explain the reasons for any deficits that occurred and state how any school experiencing a deficit is expected to finance, or deal with, that deficit; and
- (c) provide a table showing the number and cost of photocopies used by each school under the managed print contract for each year over the last 5 years?"
