#### R&O.30/2023.

Immigration (Fees) (Amendment) (Jersey) Order 2023.

Minister for Home Affairs.

This Order amends the Immigration (Fees) (Jersey) Order 2022. This Order increases the standard and express fees payable for passport applications. The express fees for applicants aged under 16 increase by 3.3%. All other standard and express fees increase by between 9.2% and 9.4% except temporary emergency passport fees, which remain unchanged. The fees were last increased with effect from 1st October 2019.

The Order was made on 3rd May 2023 and comes into force on 1st June 2023.

#### R&O.31/2023.

Road Traffic (St. Helier) (Amendment No. 39) (Jersey) Order 2023.

Minister for Infrastructure.

This Order amends the Road Traffic (St. Helier) (Jersey) Order 1996 (the "1996 Order").

Article 2 amends Schedule 1 to add in Part 1 a route for one-way traffic and in Part 3 an exemption for buses.

Article 3 amends an entry in Schedule 4 relating to part of a road on which waiting is prohibited.

Article 4 inserts a new entry into Schedule 5 where a road is closed to through traffic.

Article 5 makes various amendments to Schedule 6 to restrict vehicular access to pedestrian roads or provide for exemptions to those restrictions.

Article 6 amends an entry in Schedule 8 relating to part of a road which has a one-hour limit on paying parking places.

Article 7 amends Schedule 10, deleting one entry and adding one entry in Part 1, concerning parking a vehicle for the purposes of loading or unloading.

Article 8 amends an entry in Schedule 11 relating to the parking places for motor cycles and mopeds.

Article 9 gives the citation and provides that the Order comes into force 7 days after it is made.

The Order was made on 5th May 2023 and came into force on 12th May 2023.

#### R&O.32/2023.

Planning and Building (Cannabis) (Miscellaneous Amendments) (Jersey) Order 2023.

Minister for the Environment.

The Planning and Building (Cannabis) (Miscellaneous Amendments) (Jersey) Order 2023 amends the Planning and Building (Environmental Impact) (Jersey) Order 2006 and the Planning and Building (General Development) (Jersey) Order 2011, in respect of planning matters relating to the cultivation of cannabis and the production of cannabis products.

Article 1 amends Schedule 1 to the Planning and Building (Environmental Impact) (Jersey) Order 2006 to include within the list of developments for which an environmental impact assessment is required the construction, development or installation of a building, or the change of use of a building (in whole or in part), for the purpose of cultivation of plants of the genus *Cannabis* or for the production of products including any part of, or derivative from, plants of the genus *Cannabis*.



Article 2 amends the Planning and Building (General Development) (Jersey) Order 2011. In Schedule 1 (permitted development), Class AA in Part 3 is amended to exclude development of a building for the cultivation of plants of the genus *Cannabis* or the production of products including any part of, or derivative from, plants of the genus *Cannabis*, and alterations to enable or facilitate those purposes, so that an application for planning permission would be required in every such case. In Schedule 2 (use classes), Class D is replaced to exclude from general agricultural purposes the purpose of cultivation of plants of the genus *Cannabis*, or the production of products including any part of, or derivative from, plants of the genus *Cannabis*, so that planning permission would be required for such use.

Article 3 gives the citation and provides for commencement 7 days after the Order is made.

The Order was made on 10th May 2023 and came into force on 17th May 2023.

#### R&O.33/2023.

Financial Services (Disclosure and Provision of Information – Person with Standing) (Jersey) Order 2023. Signed by Assistant Chief Minister Deputy M.E. Millar of St. John, St. Lawrence and Trinity, for and on behalf of the Chief Minister.

The Financial Services (Disclosure and Provision of Information – Person with Standing) (Jersey) Order 2023 prescribes that a creditor of an entity is a "person with standing" for the purposes of Article 19(9) of the Financial Services (Disclosure and Provision of Information) (Jersey) Law 2020 (the "Law").

Under Article 19 of the Law, a person with standing may apply to the Royal Court for a declaration that the dissolution of an entity under Article 16(5) of the Law is void. Persons with standing include the entity itself, a significant person of the entity, a nominated person for the entity, and the Attorney General. *Article* 2 of this Order provides, under Article 19(9)(e) of the Law, that a creditor of an entity dissolved under Article 16(5) of the Law is also a person with standing.

*Article 3* provides that, before making an application to the Royal Court under Article 19 of the Law, the creditor must notify the registrar of companies that the application is to be made.

Article 4 gives the citation and provides that the Order will commence 7 days after it is made.

The Order was made on 12th May 2023 and came into force on 19th May 2023.

#### R&O.34/2023.

Proceeds of Crime (Cannabis Exemption – List of Jurisdictions) (Amendment) (Jersey) Order 2023.

Signed by Assistant Chief Minister Deputy M.E. Millar of St. John, St. Lawrence and Trinity, for and on behalf of the Chief Minister.

This Order removes South Africa from the list of jurisdictions in the Schedule to the Proceeds of Crime (Cannabis Exemption – List of Jurisdictions) (Jersey) Order 2021 to reflect the decision of the Financial Action Task Force (FATF) of 24 February 2023 to add South Africa to its list of jurisdictions under increased monitoring.

This Order comes into force 7 days after it is made.

The Order was made on 12th May 2023 and came into force on 19th May 2023.

    - (a) which suppliers are used to supply and fit carpet for rental tenants receiving Government loans for this purpose.
    - (b) whether tenants can use any company to access the best deal possible or are they limited to the named suppliers; and
    - (c) whether tenants have open choice for colour and type of carpet?"
- 40. The Chair of the States Employment Board tabled an answer on 22nd May 2023 to the following question asked by Deputy R.J. Ward of St. Helier Central
  - "Will the Chair advise how many States employees are currently receiving half pay as a consequence of long-term absence due to illness?"
- 41. The Minister for Children and Education tabled an answer on 22nd May 2023 to the following question asked by Deputy R.J. Ward of St. Helier Central
  - "Further to her response to Written Question 184/2023, in which the Minister stated that research on flexible working was due to be commissioned shortly, will she advise
    - (a) the commencement and completion date of this research;
    - (b) how it will be undertaken and when its outcomes will be implemented; and
    - (c) how many staff have been refused requests for flexible working options, such as part time or job shares, over the last 3 years?"



42. The Minister for Social Security tabled an answer on 22nd May 2023 to the following question asked by Deputy G.P. Southern of St. Helier Central –

"Further to the report from the Employment Forum entitled 'The Operation And Regulation Of Zero Hour Contracts In Jersey, Together With A Review Of Specific Employment Protections', will the Minister –

- (a) explain what actions, if any, are under consideration to provide statutory protection for continued breaches of the Employment (Jersey) Law 2003 by employers who fail to provide a statement of the terms and conditions of employment to employees, particularly those on zero-hour contracts who are not being provided with accurate statements of terms and conditions that reflect the working relationship between the parties;
- (b) commit to amending the law to enable employees to have the right to demand, rather than request, that any statement of terms and conditions accurately reflects "regular hours worked"; and
- (c) advise whether she supports the right to compensation for shift cancellation or curtailment, and if not, why not?"
- 43. The Minister for Social Security tabled an answer on 22nd May 2023 to the following question asked by Deputy G.P. Southern of St. Helier Central –

"The recent Employment Forum report 'The Operation And Regulation Of Zero Hour Contracts In Jersey, Together With A Review Of Specific Employment Protections' refers to guidance on a 48-hour per week working limit to protect the wellbeing and health of employees; what consideration has the Minister given to the potential impact of the post-Brexit removal of EU protections in the UK on such local good practice, and what further protections, if any, is she considering to ensure the maintenance of best practise?"

"Concerning the public consultation: Improving Residential Tenancies in Jersey - Residential Tenancy Law Reform proposals, will the Minister –

- (a) outline the Terms of Reference and provide details of the project scope, methodology, and anticipated outputs, including what qualitative and quantitative data that will be collected and how this will be analysed;
- (b) identify which representative groups, organisations, and individuals were consulted to inform the planning of the consultation;
- (c) outline the target audiences/stakeholder groups that the consultation aims to engage; and
- (d) outline how the consultation has been planned to ensure that it is inclusive and accessible to all the relevant stakeholder groups?"
- 45. The Assistant Chief Minister tabled an answer on 22nd May 2023 to the following question asked by Deputy L.V. Feltham of St. Helier Central –

"Will the Assistant Chief Minister with responsibility for Government communications outline –

(a) what work has been undertaken to ensure that Government communications and consultations are inclusive and accessible to all relevant stakeholder groups;



- (b) what advice she or her officers provided to the Minister for Housing and Communities or his officers about the public consultation 'Improving Residential Tenancies in Jersey Residential Tenancy Law Reform proposals' and related communications; and
- (c) the Government policy concerning provision of translations and other accessible formats?"
- 46. The Minister for Housing and Communities tabled an answer on 22nd May 2023 to the following question asked by Deputy L.V. Feltham of St. Helier Central
  - "Will the Minister provide details of any discussions he has had with the Assistant Chief Minister with responsibility for Communications about how Government communications can be improved for the Island's communities?"
- 47. The Minister for Treasury and Resources tabled an answer on 22nd May 2023 to the following question asked by Deputy R.S. Kovacs of St. Saviour
  - "On page 13 of P.80/2022 it is stated: "Based on the latest assumptions of the Fiscal Policy Panel (FPP) and work of the Income Forecasting Group (IFG), income is forecast to exceed the forecasts in the current Government Plan 2022-25 by more than the costs of these measures.", will the Minister outline
    - (a) what the latest forecasts are from the IFG or any other reliable sources, regarding income tax measures that were proposed in the 2022-2025 Government Plan; and
    - (b) by how much income from tax will exceed the earlier estimates, as per these forecasts, broken down by year across the period 2022-2025?"
- 48. The Minister for Treasury and Resources tabled an answer on 22nd May 2023 to the following question asked by Deputy R.S. Kovacs of St. Saviour
  - "Further to assurances provided in late 2022 that he would meet with the officers to work on a plan to help homeowners pressured by the increase in mortgage rates, will the Minister explain
    - (a) what actions have been taken since then for affected homeowners and what support is currently available for those impacted by this situation; and
    - (b) given the further recent rise in the Bank of England rate, what actions does the Minister intend to take to support homeowners at risk of losing their homes, if they are unable to keep up with the increased mortgage payments?"
- 49. The Minister for Economic Development, Tourism, Sport and Culture tabled an answer on 22nd May 2023 to the following question asked by Deputy R.S. Kovacs of St. Saviour –

"Regarding the Tourism Development Fund, will the Minister confirm –

- (a) whether this fund is still active, and if it is, what the current balance is, and what plans are in place for the next three years to utilise the funds; and
- (b) how much has been paid in and out of the fund each year since its establishment and to whom?"
- 50. The Minister for Home Affairs tabled an answer on 22nd May 2023 to the following question asked by Deputy G.P. Southern of St. Helier Central –



"Will the Minister advise of any ongoing or intended work in relation to updating the Matrimonial Causes (Jersey) Law 1949; and if such workstream exists, what proposed changes are included within it?"

"Given that Standard 3 of the Jersey Appointment Commission's guidelines sets out that "Each role will be advertised in such a way to encourage applicants from all sectors and groups, especially those who are under-represented at senior levels within public service"; will the Chair explain what consideration, if any, was given to this standard when the recruitment for the Director General of the Children, Young People, Education and Skills department took place?"

52. The Chair of the States Employment Board tabled an answer on 22nd May 2023 to the following question asked by Deputy C.D. Curtis of St. Helier Central –

"Further to information provided within a Freedom of Information request published on 21st April 2023, will the Chair explain why the Jersey Appointment Commission's guidelines were not followed in relation to the recruitment of the Director General for Children, Young People, Education and Skills?"
