## **Explanatory Note regarding subordinate legislation tabled at this meeting.**

### **R&O.73/2023.**

Sanctions and Asset-Freezing (Amendment of Law and Order No. 2) (Jersey) Order 2023.

*Signed by Assistant Minister Deputy I.J. Gorst of St. Mary, St. Ouen and St. Peter, for and on behalf of the Minister for External Relations.*

This Order amends the Sanctions and Asset-Freezing (Jersey) Law 2019 (the “Sanctions Law”) and the Sanctions and Asset-Freezing (Implementation of External Sanctions) (Jersey) Order 2021 (the “Sanctions Order”).

#### *Part 1 – amendment of the Sanctions Law*

*Article 1* amends Article 2A of the Sanctions Law, which defines what is meant by the terms “owned”, “held”, “controlled”, “directly” and “indirectly” for the purposes of the Sanctions Law.

Article 2A(4) to (8) defines when a person who is not an individual (“C”) is owned, held or controlled directly or indirectly by another person (“P”). Before the amendment made by this Order, that is when one or more of 3 conditions is satisfied.

The first condition is that P is the holding body, or beneficial owner, of C.

The second condition is that P directly or indirectly holds more than 50% of the shares in C or more than 50% of the voting rights in C, or that P holds the right directly or indirectly to appoint or remove a majority of the board of directors of C.

The third condition is that it is reasonable to expect that P can secure, in most cases or in significant respects, that the affairs of C are conducted in accordance with P’s wishes.

This Order removes the first condition.

#### *Part 2 – amendment of the Sanctions Order*

*Articles 3 to 6* amend the Sanctions Order in relation to UK sanctions on Russia and the Republic of Belarus, by making further provision about the automatic effect of UK general licences. A general licence allows a person to do something which is otherwise prohibited by the Sanctions Order or the Sanctions Law.

##### *Russia*

Paragraph 4(2) of Schedule 3 to the Sanctions Order provides that, if the UK grants a general licence under the UK’s Russia (Sanctions) (EU Exit) Regulations 2019 (S.I. 2019/855, as amended, the “UK Russia Regulations”), then that general licence has automatic effect in Jersey. The Minister can grant a general licence that expressly modifies or disapplies a UK general licence. The Minister can also disapply a UK general licence altogether, without making any replacement, by publicising a notice in the same way that notices of revocation of Jersey general licences are publicised.

But a UK general licence has automatic effect under paragraph 4(2) only if it does not relate solely to asset-freeze provisions in the UK Russia Regulations, and only in relation to an act which would otherwise be an offence under Article 4 of the Sanctions Order (that is, an offence under a provision which is not an asset-freeze provision).

Amendments made by this Order provide for UK general licences granted under the UK Russia Regulations to have automatic effect in Jersey without the limitations described in the previous paragraph.

##### *Belarus*

Amendments made by this Order provide that, if the UK grants a general licence under the UK’s Republic of Belarus (Sanctions) (EU Exit) Regulations 2019 (S.I. 2019/600, as amended, the “UK Belarus Regulations”), then that general licence has automatic effect in Jersey. The effect of these amendments is to replicate, for general licences under the UK Belarus Regulations, the amended provisions described above in relation to general licences under the UK Russia Regulations.

This Part also makes minor consequential changes to the Sanctions Order.

#### *Part 3 – final provisions*

*Article 7* gives the name of the Order and provides that it comes into force 7 days after it is made.



The Order was made on 11th September 2023 and came into force on 18th September 2023.

**R&O.76/2023.**

States of Jersey (Transfer of Justice Functions – Chief Minister to Justice and Home Affairs) Order 2023.  
*Chief Minister.*

This Order –

- (a) renames the Minister for Home Affairs as the Minister for Justice and Home Affairs and makes amendments to legislation consequential on that renaming; and
- (b) amends legislation to transfer statutory functions in relation to justice to the Minister for Justice and Home Affairs from the Chief Minister.

Functions under the following legislation are transferred to the Minister for Justice and Home Affairs from the Chief Minister –

- Access to Justice (Jersey) Law 2019;
- Criminal Procedure (Jersey) Law 2018;
- The Law Society of Jersey Law 2005 (although the power to amend by Order the definition of “limited liability partnership” in this Law will remain with the Chief Minister).

This Order comes into force 7 days after it is made.

The Order was made on 14th September 2023 and came into force on 21st September 2023.

**R&O.77/2023.**

Social Security (Incapacity Benefits – Phased Return to Work) (Amendment) (Jersey) Order 2023.  
*Minister for Social Security.*

This Order amends the Social Security (Incapacity Benefits) (Jersey) Order 2004 to provide that a day is to be treated as a day of incapacity for work if a person undertakes activity that is part of an agreed plan to assist with the person’s return to work. The Order comes into force 7 days after it is made.

The Order was made on 19th September 2023 and came into force on 26th September 2023.

**R&O.78/2023.**

Control of Housing and Work (Temporary Exemption – Amendment No. 4) (Jersey) Order 2023.

*Signed by Assistant Chief Minister Deputy L.K.F. Stephenson of St. Mary, St. Ouen and St. Peter, for and on behalf of the Chief Minister.*

This Order amends the Control of Housing and Work (Temporary Exemption) (Jersey) Order 2021 so that its expiry is extended by 1 year to the end of 31st December 2024.

The Order was made on 20th September 2023 and came into force on 27th September 2023.

**R&O.79/2023.**

Planning and Building (Special Development – Haut du Mont) (Jersey) Order 2023.

*Minister for the Environment.*

The Planning and Building (Special Development – Haut du Mont) (Jersey) Order 2023 is made by the Minister for the Environment under Articles 8 and 124 of the Planning and Building (Jersey) Law 2002 (“the Law”), and grants planning permission for the demolition of the relevant property at Haut du Mont,



Pier Road, St. Helier. The developer, supported by the Haut du Mont Recovery Coordinating Group which was established by the Chief Minister following the incident on 10th December 2022, submitted an application to the Minister on 12th April 2023 for the making of a Special Development Order to grant this planning permission, and submitted supporting information on 23rd May 2023. This Order does not grant planning permission for development of the site following demolition of the relevant property, an application under Article 9 of the Law will be required.

*Article 1* contains definitions: “demolition” has the meaning given in Article 3; “developer” means Andium Homes Limited; “relevant property” means the apartment buildings on the site containing a total of 9 residential units; and “site” means the land at Haut du Mont, Pier Road, St. Helier, indicated with cross-hatching on the plan in the *Schedule*.

*Article 2* grants planning permission for demolition of the relevant property, in consideration of the exceptional circumstances surrounding the incident at Haut du Mont on 10th December 2022, and the resultant loss of life and extensive damage to the property.

*Article 3* provides that the developer must ensure that demolition of the relevant property does not commence until notified by the Minister in writing of the date on or after which demolition may commence, and must ensure completion of the demolition within 6 weeks, subject to extension up to 12 weeks if completion of the demolition within 6 weeks is not possible. “Demolition” is defined as demolition of the relevant property and related structures, removal of all associated building materials and securing of the site, in accordance with Ministerial guidelines.

*Article 4* set outs the conditions subject to which planning permission is granted. The developer must, within 6 months, submit to the Minister a detailed proposal regarding the development of the site and a detailed proposal regarding the development of residential units at another location to replace demolished units, and ensure compliance with a waste management plan for the site approved by the Chief Officer.

*Article 5* provides that nothing in the Order exempts the developer or any other person from compliance with Building Bye-laws made under the Law or any other applicable enactment.

*Article 6* gives the citation, and provides that the Order comes into force 7 days after it is made.

The Order was made on 21st September 2023 and came into force on 28th September 2023.

### **R&O.80/2023.**

Road Traffic (Disabled Persons) (Badges for Motor Vehicles) (Amendment No. 3) (Jersey) Order 2023.

*Minister for Infrastructure.*

This Order amends the Road Traffic (Disabled Persons) (Badges for Motor Vehicles) (Jersey) Order 1982 (the “1982 Order”) by updating Article 3 (description of disabled persons) of the 1982 Order to correct a reference to the Jersey Blind Society Incorporated to EYECAN and to make that Article gender silent in line with modern drafting style.

This Order comes into force 7 days after it is made.

The Order was made on 21st September 2023 and came into force on 28th September 2023.

### **R&O.81/2023.**

Road Traffic (Disabled Persons) (Parking) (Amendment No. 13) (Jersey) Order 2023.

*Minister for Infrastructure.*

This Order amends the Road Traffic (Disabled Persons) (Parking) (Jersey) Order 2002 by creating new parking places for disabled persons – one in St. Helier and 2 in Grouville.

This Order comes into force 7 days after it is made.

The Order was made on 21st September 2023 and came into force on 28th September 2023.





**R&O.82/2023.**

Road Traffic (Grouville) (Amendment No. 11) (Jersey) Order 2023.

*Minister for Infrastructure.*

This Order amends the Road Traffic (Grouville) (Jersey) Order 2002 (the “2002 Order”).

*Article 1* provides that the Order amends the 2002 Order.

*Article 2* amends Schedule 1 by creating an exemption to the one-way traffic route on La Sente Brée for patient transport vehicles and ambulances that are leaving The Hollies Day Centre.

*Article 3* amends Schedule 2 to prohibit waiting on lengths of La Rue Hilgrove and La Sente Brée.

*Article 4* amends Schedule 6 to add a 3-hour parking disc restriction on a length of La Rue Hilgrove.

*Article 5* introduces the Schedule that contains minor housekeeping amendments.

*Article 6* gives the citation and provides that this Order comes into force 7 days after it is made.

The Order was made on 21st September 2023 and came into force on 28th September 2023.

**R&O.83/2023.**

Road Traffic (St. Helier) (Amendment No. 41) (Jersey) Order 2023.

*Minister for Infrastructure.*

This Order amends the Road Traffic (St. Helier) (Jersey) Order 1996, in relation to Commercial Buildings, to –

- reduce the paying parking places on the east side by one bay;
- make some amendments to the lengths of the parking areas on the west and south sides; and
- improve the clarity of the descriptions of existing paying parking places.

This Order comes into force 7 days after it is made.

The Order was made on 21st September 2023 and came into force on 28th September 2023.

**R&O.84/2023.**

Immigration (Fees) (Amendment No. 2) (Jersey) Order 2023.

*Minister for Justice and Home Affairs.*

This Order amends the Immigration (Fees) (Jersey) Order 2022 (the “Fees Order”).

*Article 2* amends Article 2 of the Fees Order to –

- increase the fees payable for 7 of the categories of people making applications for leave to remain in Jersey for a limited period.
- introduce a new fee for applications in respect of ministers of religion. The fee for those types of applicants previously fell within the category described in row 7 of the table.
- remove the fee entry in the table for the dependents of people with a work permit under row 5 that is to be or has been extended for a further period. This fee is no longer relevant.
- clarify that the fee in row 7 of the table applies to work permit holders who do not fall within any of the categories of temporary work permit holders described in rows 4, 5 and 6 of the table.

The percentage uplift and date of the previous uplift or introduction of each fee in the table in Article 2 is as follows –

*Article 4* gives the title by which this Order may be cited and provides for the Order to come into force on 4th October 2023.

The Order was made on 26th September 2023 and come into force on 4th October 2023.

“In respect of the Education Partnership between the States of Jersey and the NASUWT (National Association of Schoolmasters Union of Women Teachers) signed in September 2014 (Education Partnership), will the Chair confirm whether it is still in place and adhered to; and, given the start of discussions on terms and conditions (T&Cs) with the Unions will the Chair provide details as to –



- (a) how this agreement affects these discussions;
  - (b) whether all teaching unions have equal involvement in the development of T&Cs;
  - (c) whether discussions in respect of T&Cs and pay for lecturers at Highlands College include all unions or just one single union;
  - (d) the extent to which unions are able to attend meetings and have their voices heard; and
  - (e) how the final agreement will be decided across all unions?”
22. The Minister for Children and Education tabled an answer on 25th September 2023 to the following question asked by Deputy R.J. Ward of St. Helier Central –
- “Will the Minister provide details of the meetings which have taken place between CYPES and the teaching unions with regard to Terms and Conditions since 2014, to include the following –
- (a) the dates and attendees at each meeting;
  - (b) the extent to which the Education Partnership affects (or has affected) any discussions;
  - (c) whether lecturers at Highlands College are represented by all unions or one single union; and
  - (d) the scheduled dates for any future meetings?”
23. The Minister for Economic Development, Tourism, Sport and Culture tabled an answer on 25th September 2023 to the following question asked by Deputy R.J. Ward of St. Helier Central –
- “Will the Minister advise what discussions, if any, have taken place between his department, Jersey Post and the Channel Island Cooperative Society regarding the closure of post offices within certain stores; and whether any impact assessment of these closures has been undertaken by the Minister?”
24. The Minister for Infrastructure tabled an answer on 25th September 2023 to the following question asked by Deputy L.V. Feltham of St. Helier Central –

- (c) tenants in private sector accommodation?”

28. The Minister for Treasury and Resources tabled an answer on 2nd October 2023 to the following question asked by Deputy R.S. Kovacs of St. Saviour –

“Regarding the new taxes outlined in page 44 and 46 of the Proposed Government Plan 2024-2027, will the Minister –

- (a) explain the intended process and charges for –
  - (i) domestic liquid waste;
  - (ii) domestic household waste; and
  - (iii) revenue to replace Road Fuel Duty with a Vehicle Tax;

“Will the Minister explain how she develops policy to protect children under her care from activist driven agendas promoted by some sections of society?”

“Will the Minister provide an update on progress delivering MSS P5: Conducting a review of our benefits landscape, to ensure that benefits are well-targeted, modern and effective, as set out in her Delivery Plan, including –

- (a) the actions identified following completion of the MSS P5.1 review, including details of the work plan developed, and progress against that work plan;
- (b) what specific groups were included in the work undertaken on MSS P5.2, the findings of this review, or work to date if the review is ongoing; and
- (c) outlining the work undertaken on MSS P5.3 to ensure that the IT system delivered by the Transform Project will support and deliver any future changes to benefits that the States Assembly may decide upon?”

37. The Minister for Social Security tabled an answer on 2nd October 2023 to the following question asked by Deputy L.V. Feltham of St. Helier Central –

“Will the Minister provide details of the total cost of delivering MSS P1.5 from her Delivery Plan, from 2022 to date, breaking down expenditure by staff costs, contractor costs, costs of products, and any other costs incurred, such as promotional costs?”

38. The Minister for Health and Social Services tabled an answer on 2nd October 2023 to the following question asked by Deputy G.P. Southern of St. Helier Central –

“Regarding the 3 options for sustainable health funding outlined on page 96 of the Proposed Government Plan 2024-2027, will the Minister provide details on the following –

- (a) how each of the options will be financed;
- (b) how the Government will engage with healthcare providers; and
- (c) what reforms are proposed for the Health Insurance Fund?”

- (e) provide the total cost of the Vaccination Centre from 2020 to date, broken down per year, alongside the expected total cost for the rest of this year?”

“Following the publication of the Government Plan 2024 -2027, would the Minister provide a detailed breakdown of the £675m estimated cost for the acute hospital at Overdale?”

43. The Minister for Health and Social Services abled an answer on 2nd October 2023 to the following question asked by Deputy M.R. Scott of St. Brelade –

“Will the Minister advise what progress is being made in implementing the recommendations of the 2022 Review of Health and Community Services (HCS) Clinical Governance Arrangements within Secondary Care and provide –

- (a) the reason for the distinction between mental and physical health within the scope of the report;
- (b) the rationale for separating the crisis team from the home treatment team and the evidence on which this decision was based;
- (c) clarity on why an individual has been engaged to look at clinical governance in mental health, separate from the clinical governance team based in the general hospital; and
- (d) evidence of any consideration given to the possible creation of a silo in these areas that could increase risk of error?”



44. The Minister for Health and Social Services abled an answer on 2nd October 2023 to the following question asked by Deputy M.R. Scott of St. Brelade –

“Will the Minister detail what progress is being made in delivering updated operational policies across all areas of healthcare in accordance with the Quality and Improvement in Healthcare process, in particular in the area of mental health, and provide the following information –

- (a) a copy of the rapid tranquiliser policy used by the inpatient department and, if none is available, advice on when this will be produced and published;
- (b) the official operational policy for inpatient care;
- (c) an explanation of the process by which the crisis team operational policy was constructed, and what feedback was obtained from clinicians and staff working in mental health;
- (d) details of the ethical conduct policy for managers within health and an explanation of who is responsible for enforcing policy; and
- (e) the process used to define mild, moderate and urgent cases within mental health, and who has responsibility for determining the categorisation of cases in the absence of a published operational policy for mental health?”

45. The Minister for Health and Social Services abled an answer on 2nd October 2023 to the following question asked by Deputy M.R. Scott of St. Brelade –

“Will the Minister provide details of the turnover in mental health staff for each of the last three years. including a breakdown between clinicians and non-clinicians?”

Discretion is exercised by the Presiding Officer in accordance with guidance issued by the Bailiff, following consultation with the Privileges and Procedures Committee. The current guidance was presented to the States in the report 'Time Limits on Speeches in Debates: Guidance on the Exercise of Discretion' (R.3/2021). The report states that discretion may be exercised to allow for a longer speech than 15 minutes where the member speaking is designated as the 'main respondent' to the debate.
