Bankruptcy (Désastre) (Amendment No. 3) (Jersey) Order 2023.

Signed by Assistant Chief Minister Deputy M.E. Millar of St. John, St. Lawrence and Trinity, for and on behalf of the Chief Minister.

This Order amends Article 5 of the Bankruptcy (Désastre) (Jersey) Order 2006.

The amendments increase the prescribed maximum amounts payable under Article 32(1)(b)(i) and (ii) of the Bankruptcy (Désastre) (Jersey) Law 1990. The amounts are payable to an employee of a debtor in respect of an amount due to the employee at the date of the declaration *en désastre* in respect of arrears of –

- wages or salary for services rendered to the debtor during the 6 months immediately preceding the declaration, and
- holiday pay and bonuses.

These prescribed amounts were last increased in April 2018.

This Order comes into force 7 days after it is made.

The Order was made on 7th November 2023 and came into force on 14th November 2023.

Control of Housing and Work (Guidance on Temporary Absence and Significant Ownership) (Amendment No. 4) (Jersey) Order 2023.

Signed by Assistant Chief Minister Deputy L.K.F. Stephenson of St. Mary, St. Ouen and St. Peter, for and on behalf of the Chief Minister.

This Order amends the Control of Housing and Work (Guidance on Temporary Absence and Significant Ownership) (Jersey) Order 2013.

The Chief Minister issued new guidance in October 2023 concerning the effect on a person's residential and employment status of any temporary absence from Jersey. It replaces guidance issued in May 2019. The amendments give effect to the new guidance starting on the day on which this Order comes into force, which is 7 days after the Order is made.

The Order was made on 9th November 2023 and came into force on 16th November 2023.

Long-Term Care (Benefits) (Amendment No. 12) (Jersey) Order 2023.

Minister for Social Security.

This Order amends the Long-Term Care (Benefits) (Jersey) Order 2014 (the "2014 Order") to increase by approximately 7.7% –

- the rates of long-term care benefit for weekly standard care costs (specified in Article 8 of the 2014 Order) (*Article 2*);
- the amounts that a person must pay towards the weekly costs of living in an approved home and for incidental expenses (specified in Article 9 of the 2014 Order) (*Article 3*);



- the amounts that a person must pay towards the person's standard care costs before the person qualifies to receive a long-term care benefit for standard care costs (specified in Article 10 of the 2014 Order) (Article 4);
- the amount that may be loaned to a person to enable the person to pay the costs of living in an approved home (specified in Article 12 of the 2014 Order) (*Article 5*).

These rates and amounts were last increased with effect from 1st January 2023.

This Order comes into force on 1st January 2024.

The Order was made on 9th November 2023 and comes into force on 1st January 2024.

Long-Term Care Services (Health and Social Services Charges) (Amendment No. 11) (Jersey) Order 2023. *Minister for Health and Social Services*.

This Order amends the Long-Term Care Services (Health and Social Services Charges) (Jersey) Order 2014 to increase, by approximately 7.7%, the charges specified in that Order for care services provided in a care home or group home. These charges were last increased with effect from 1st January 2023.

The charges specified for each level of long-term care services have been calculated as follows:

rate for long-term care benefit for the equivalent level of standard care

+

amount that a person must pay towards the weekly costs of living in an approved home, excluding incidental expenses

The rate for long-term care benefit is prescribed in Article 8 of the Long-Term Care (Benefits) (Jersey) Order 2014 (the "Benefits Order"), and the amount that a person must pay towards the weekly costs of living in an approved home are prescribed in Article 9(c) of the Benefits Order, and both are to be increased for 2024.

This Order comes into force on 1st January 2024.

The Order was made on 9th November 2023 and comes into force on 1st January 2024.

Home Affairs (Fire and Rescue and Petroleum – 2024 Fees) (Jersey) Order 2023.

Minister for Justice and Home Affairs.

This Order increases the fees payable under the following Orders –

- (a) the Fire Precautions (Fees) (Jersey) Order 2010, by between 2% and 2.3%;
- (b) the Fire and Rescue Service (Charges) (Jersey) Order 2012, by between 1.9% and 2.4%; and
- (c) the Petroleum (Licensing) (Fees) (Jersey) Order 2012, by between 2.2% and 2.5%.

These fees were last increased with effect from 1st January 2023.

This Order also amends the Fire Precautions (Fees) (Jersey) Order 2010 to provide for a minimum fee for an application for a fire certificate, and to clarify that the fee for a replacement fire certificate also applies to an application for renewal of a fire certificate. It makes minor clarificatory amendments to the Fire and Rescue Service (Charges) (Jersey) Order 2012, and makes minor amendments to apply current drafting practice to the Petroleum (Licensing) (Fees) (Jersey) Order 2012.

The Order was made on 16th November 2023 and comes into force on 1st January 2024.

This Order renames the Minister for Economic Development, Tourism, Sport and Culture as the Minister for Sustainable Economic Development, and makes amendments to legislation consequential on that renaming.

The Order comes into force 7 days after it is made.

The Order was made on 17th November 2023 and came into force on 24th November 2023.

R&O.103/2023.

Nursing Homes (2024 Fees) (Jersey) Order 2023.

Chief Minister.

This Order amends the Nursing Homes (General Provisions) (Jersey) Order 1995. It comes into force on 1st January 2024.

The amendments increase by 2.5% –

- the fee payable for an application for registration by a person carrying on, or intending to carry on, a nursing home;
- the fee payable for an application for registration by another person who is, or is intended to be, in charge of a nursing home; and
- the annual fee payable by a registered person.

The fees were last increased on 1st January 2023.

The Order was made on 20th November 2023 and comes into force on 1st January 2024.

R&O.104/2023.

Cremation (Fees – Amendment) (Jersey) Order 2023.

Minister for Health and Social Services.

The Cremation (Fees – Amendment) (Jersey) Order 2023 amends the Cremation (Fees) (Jersey) Order 2007 to increase the fee for cremating the remains of a person aged 18 or over from £738.50 to £828, an increase of 12.1%. Approval for this increase has been granted by Treasury. The fee for cremating the remains of a person aged under 18 remains nil. The Order also increases the maximum fee that a medical practitioner may charge for completing the medical certificate required by Regulation 6(a) of the Cremation (Jersey) Regulations 1961 from £82 to £100, an increase of 22%. The fees were last increased on 1st January 2017. The Order comes into force on 1st January 2024.

The Order was made on 23rd November 2023 and comes into force on 1st January 2024.

R&O.105/2023.

Road Traffic (Speed Limits) (Amendment No. 17) (Jersey) Order 2023.

Minister for Infrastructure.

This Order amends the Road Traffic (Speed Limits) (Jersey) Order 2003 by reducing speed limits on roads or sections of roads in Trinity as follows –



- 5 reductions from 40 mph to 30 mph,
- 2 reductions from 40 mph to 20 mph, and
- 7 reductions from 30 mph to 20 mph.

The Order was made on 24th November 2023 and comes into force on 30th November 2023.

R&O.106/2023.

Road Traffic (Miscellaneous Amendments – Electric Vehicle Parking) (Jersey) Order 2023. *Minister for Infrastructure*.

The Road Traffic (Miscellaneous Amendments – Electric Vehicle Parking) (Jersey) Order 2023 amends the Road Traffic (St. Helier) (Jersey) Order 1996 (the "St. Helier Order") to redesignate 2 parking bays on the eastern arm of The Parade as electric vehicle recharging bays. The Order also takes the opportunity to tidy up some obsolete cross-references in the St. Helier Order.

Article 1 provides that this Order amends the St. Helier Order.

Article 2 inserts the definition "electric vehicle" into Article 2 of the St. Helier Order. This definition is deleted from Article 27B of the St. Helier Order by *Article 8* since it now applies to the whole of the St. Helier Order instead of only applying to Article 27B.

Article 3 amends Article 10 of the St. Helier Order to include the new electric vehicle recharging bays in the definition "parking" and to tidy up 2 obsolete cross-references.

Article 4 amends Article 11 of the St. Helier Order to designate the new electric vehicle recharging bays, between 9 a.m. and 10 p.m. every day, as paying parking spaces with a 2-hour limit. At other times, the 2-hour limit does not apply and there is no charge for parking, although the bays may still only be used by electric vehicles.

Articles 5 to 7 amend Articles 20, 21 and 21A, respectively, of the St. Helier Order to tidy up obsolete cross-references to previously deleted Parts of Schedule 8 to the St. Helier Order.

Article 9 inserts a new Article 27C into the St. Helier Order. This new Article provides that a vehicle must not park in an electric vehicle recharging bay unless it is an electric vehicle and is connected to an electric vehicle recharging point. The new Article 27C also defines "electric vehicle recharging bay" and "electric vehicle recharging point" for the purpose of that Article.

Article 10 amends Schedule 8 to the St. Helier Order to –

- (a) add the designation of 2 parking bays on the Esplanade as car club parking bays under Article 27B of the St. Helier Order;
- (b) remove the designation of 2 parking bays on the eastern arm of The Parade as car club parking bays; and
- (c) designate 2 parking bays on the eastern arm of The Parade as electric vehicle recharging bays under Article 27C of the St. Helier Order.

Article 11 gives the title of the Order and provides for it to come into force 7 days after it is made.

The Order was made on 24th November 2023 and comes into force on 1st December 2023.
