Explanatory Note

These Regulations increase from £37 to £38 the fee payable on the first examination of a vehicle for its suitability as a public service vehicle, and (effectively) from £18.50 to £19 the fee payable for a re-examination within 30 days.

These Regulations also increase the fees payable for applications for licences to drive public service vehicles. Where the application relates to driving a vehicle of a class for which the applicant has not previously held a licence, the component fees are to become -

- (a) £61.50 instead of £60 for each practical test;
- (b) £49 instead of £48 for a cab driver's test on knowledge of the Island;
- (c) £33 instead of £32 for a char-à-banc driver's test on knowledge of the Island.

In other cases, the fee is to become £7.80 instead of £7.60.

The Regulations come into force on 1st January 2000.

THE STATES, in pursuance of Articles 49A and 54 of the Motor Traffic (Jersey) Law 1935, as amended, have made the following Regulations -

1. For the scale of fees in Regulation 1 of the Public Service Vehicles (Fees) (Jersey) Regulations 1991,² as amended³ (hereinafter referred to as "the principal Regulations"), there shall be substituted the following scale of fees -

"Class of vehicle	Fee
Omnibus	£38
Char-à-banc, being a road train within the meaning of the Law, for each motor tractor or trailer	£38
Any other char-à-banc	£38
Cab	£38".

- 2. In Regulation 4 of the principal Regulations -
- (a) in sub-paragraph (a)(A) for the matter "£60" there shall be substituted the amount "£61.50";
- (b) in sub-paragraph (a)(B) for the matter "£48" there shall be substituted the matter "£49";
- (c) in sub-paragraph (a)(C) for the matter "£32" there shall be substituted the matter "£33";
- (d) in sub-paragraph (b) for the matter "£7.60" there shall be substituted the matter "£7.80".
- 3. The Public Service Vehicles (Fees) (Amendment No. 9) (Jersey) Regulations 1998⁴ are repealed.
- **4.** These Regulations may be cited as the Public Service Vehicles (Fees) (Amendment No. 10) (Jersey) Regulations 1999 and shall come into force on the first day of January 2000.
