#### Report

The purpose of the Appointed Day Act is to bring into force the Companies Amendment No. 6) (Jersey) Law 2002 ("**Amendment No. 6**'), which was approved by the States of Jersey on 17th July 2001, sanctioned by Order of Her Majesty in Council on 12th February 2002 and registered in the Royal Court on 8th March 2002.

Among the more significant changes made to the Companies (Jersey) Law 1991 by Amendment No. 6 are-

- (a) The ability to establish new types of company, including a company with unlimited liability, a guarantee company, a company issuing shares of no par value and various combinations of these.
- (b) The ability for a private company to be formed with a single member.
- (c) Provisions that will allow two or more companies to merge.
- (d) The introduction of provisions that will allow a foreign company to apply to continue as a Jersey company and for a Jersey incorporated company to seek to continue in another jurisdiction.

Amendment No. 6 also makes consequential amendments to the Borrowing Control (Jersey) Law 1947 to enable Orders to be made to regulate -

- (a) a company that is to have one or more guarantor members; and
- (b) an overseas company that applies for a certificate to be able to continue as a Jersey company.

This draft Act has no implications for the financial or manpower resources of the States.

## **Explanatory Note**

The purpose of this Act is to appoint 1st July 2002 as the day for the commencement of the Companies (Amendment No. 6) (Jersey) Law 2002.

The Law was adopted by the States on 17th July 2001 (P.29 of 2001, as amended).

- 2. This Act may be cited as the Companies (Amendment No. 6) (Jersey) Law 2002 (Appointed Day) Act 200.
