## DRAFT EXTRADITION (DESIGNATED TERRITORIES) (JERSEY) REGULATIONS 200-

#### REPORT

The Extradition (Jersey) Law 2004 ("the Extradition Law") was registered in the Royal Court on 3rd September 2004, and came into force on 1st October 2004.

Article 6 of the Extradition Law made provision in respect of 'designated territories', that is to say, territories to which extradition from Jersey is possible. It provided that a designated territory is a territory specified in Schedule 1 to the Extradition Law. The States were empowered by Regulations to specify territories for inclusior in Schedule 1.

On 28th September 2004, the States enacted the Extradition (Designated Territories) (Jersey) Regulations 2004 ("the 2004 Regulations") listing a number of countries as designated territories.

The purpose of the Draft Regulations is to go on to designate 7 additional territories of the first category which were omitted inadvertently from the list contained in the 2004 Regulations. Those territories are Belgium, Denmark, Finland, Ireland, Portugal, Spain and Sweden, which are already designated territories for the purpose of the equivalent legislation of the United Kingdom.

There are no financial or manpower implications for the States arising from these Draft Regulations.

### **Explanatory Note**

These Regulations would designate Belgium, Denmark, Finland, Ireland, Portugal, Spain and Sweden as territories of the first category for the purposes of the Extradition (Jersey) Law 2004.

The effect of designation under this category would be -

- (a) to enable Jersey to entertain a request from such a country for the extradition of a person in Jersey, and
- (b) to allow the Magistrate, in doing so, to act on information other than evidence.

The Regulations would come into force on the day after they are made.

#### **1** Designated territories of the first category

The territories specified in the Schedule to these Regulations are specified as territories in Part 1 of Schedule 1 to the Extradition (Jersey) Law 2004. [2]

#### 2 Citation and commencement

- (1) These Regulations may be cited as the Extradition (Designated Territories) (Jersey) Regulations 200-.
- (2) These Regulations shall come into force on the day after they are made.
