## DRAFT STATES OF JERSEY LAW 2005 (APPOINTED DAY) (No. 1) ACT 200

#### **REPORT**

As explained in the Explanatory Note the purpose of this Appointed Day Act is simply to bring into force Article 6 of the States of Jersey Law 2005 to enable the Senators and Deputies elections to be ordered and held according to that Article.

Members will have noted that the Committee has also lodged the draft States of Jersey (Period for Ordinary Election) (Jersey) Regulations 200- (P.131/2005) which should be read in conjunction with this projet. The effect of the 2 projets, if adopted, is that the elections for Deputies will be able to take place on 23rd November 2005 for the reasons explained in the report accompanying the draft States of Jersey (Period for Ordinary Election) (Jersey) Regulations 200-.

The remaining provisions of the States of Jersey Law 2005 that are not yet in force will be the subject of a further Appointed Day Act later this year.

There are no financial or manpower implications arising from this Appointed Day Act.

#### **Explanatory Note**

This Act would bring into force Article 6 of the States of Jersey Law 2005. Article 6 states the periods within which ordinary elections for Senators and Deputies must be held and enables the States to make Regulations changing those periods.

The Act would also commence the repeal of Article 12 of the States of Jersey Law 1966, which currently provides for the periods within which ordinary elections for Senators and Deputies must be held, and partially commences an amendment to the Public Elections (Jersey) Law 2002 so as to require the Royal Court to order the holding of the ordinary elections when they are due under the said Article 6.

**THE STATES**, in pursuance of Article 53(3) of the States of Jersey Law 2005,  $^{[\![1]\!]}$  have made the following Act –

#### 1 Provisions commenced

The following provisions of the States of Jersey Law 2005 shall come into force 7 days after this Act is made –

- (a) Article 6;
- (b) Article 52(1), to the extent that it gives effect to paragraph 4 of Part 1 of Schedule 3;
- (c) Article 52(2), to the extent that it gives effect to the repeal, by Part 2 of Schedule 3, of Article 12 of the States of Jersey Law 1966; [2]
- (d) paragraph 4 of Part 1 of Schedule 3, for the purposes only of the commencement of the said Article 6;
- (e) Part 2 of Schedule 3, to the extent that it repeals Article 12 of the States of Jersey Law 1966.

#### 2 Citation

This Act may be cited as the States of Jersey Law 2005 (Appointed Day) (No. 1) Act 200.
