# DRAFT HARBOURS (AMENDMENT No. 40)(JERSEY) REGULATIONS 200-

#### **REPORT**

In order to make best use of open space for working and moving items through the Harbours, there is a system of Quay Inspection in which, where items stay beyond a prescribed free period, a daily fine is imposed.

There are no manpower implications and the financial implications are as follows.

In order to maintain the effectiveness of this sanction it is proposed that the fines be increased by 3.6% (Jersey Retail Price Index).

## **Explanatory Note**

These Regulations would increase, by 3.6%, the daily fine imposed in respect of goods which remain on a harbour beyond the prescribed period.

The fines were last increased 1 year ago.

**THE STATES**, in pursuance of Article 4 of the Harbours (Administration) (Jersey) Law 1961<sup>[1]</sup>, have made the following Regulations –

#### 1 Schedule 1 amended

For Part 2 of Schedule 1 to the Harbours (Jersey) Regulations  $1962^{\boxed{2}}$  there shall be substituted the following Part –

The Harbours (Amendment No. 39) (Jersey) Regulations  $2005^{\boxed{31}}$  shall be revoked.

- (1) These Regulations may be cited as the Harbours (Amendment No. 40) (Jersey) Regulations 200.
- (2) These Regulations shall come into force on 1st January 2007.
