REPORT

The Draft Public Holidays and Bank Holidays (Amendment No. 5) (Jersey) Act 202-, if approved, would provide for a public holiday on Monday 19th September 2022 to coincide with the funeral of Her late Majesty Queen Elizabeth II.

The thoughts of Islanders are with the Royal Family and His Majesty The King at this sad time.

Throughout her seven decades on the throne, Her Majesty's diligent and dutiful public service was an inspiration to us all. Here in Jersey, La Reine, Notre Duc – the Queen, Our Duke – connected our Island to the wider British family and the Commonwealth. It is therefore only fitting that we emulate the arrangements across the United Kingdom to also provide a public holiday here in Jersey on the occasion of Her late Majesty's funeral.

Financial and manpower implications

In terms of Government and non-Ministerial departments, the cost of paying staff who would have otherwise worked is estimated as £1.38 million per day. This is not an additional cost to the States.

EXPLANATORY NOTE

This Act, if passed, would amend Part 2 of the Schedule to the Public Holidays and Bank Holidays (Jersey) Act 2010 to specify that Monday 19th September 2022, the day of the funeral of Her late Majesty Queen Elizabeth II, is to be observed as a public holiday.

The Act, if passed, would come into force on the day after it is made.

THE STATES make this Act under Article 2 of the <u>Public Holidays and Bank Holidays (Jersey) Law 1951</u> –

1 Public Holidays and Bank Holidays (Jersey) Act 2010 amended

In Part 2 of the Schedule to the <u>Public Holidays and Bank Holidays (Jersey)</u> <u>Act 2010</u> –

- (a) the existing paragraph is renumbered as paragraph 1;
- (b) after renumbered paragraph 1 there is inserted –

"2 2022: Funeral of Her Majesty Queen Elizabeth II

Monday 19th September 2022 is to be observed as a public holiday.".

2 Citation and commencement

This Act may be cited as the Public Holidays and Bank Holidays (Amendment No. 5) (Jersey) Act 202- and comes into force on the day after it is made.
