#### 1 PAGE 2, PART 2 -

In the table adding a new priority, substitute the words "Natural Environment" with "Sustainable Resources".

#### 2 PAGE 2, PART 3 -

After the words "We will reform our planning service to enable sustainable development in Jersey and the frictionless use of our existing Laws and policies contained within the Bridging Island Plan."

there should be inserted the following –

"Changes will include developing and introducing a fast-track service process for minor applications and improving customer service throughout. We will also deliver improved planning guidance and explore the relaxation of planning control to enable Islanders to undertake more work without the need for planning permission."

#### 2 PAGE 3, PART 4 –

In paragraph 4, for the words "with the aim of being carbon neutral by 2035" substitute the words "committing to an emissions reduction pathway in line with the Paris Agreement and net-zero by 2050."

#### **REPORT**

This amendment to the Panel's initial amendment brings together wording which has been agreed by both the Minister for the Environment and the Environment, Housing and Infrastructure Panel.

It incorporates the wording and vision which had been sought by the Council of Ministers in what is now a withdrawn amendment to the Panel's original and also maintains the changes which the Panel had been keen to see implemented.

It has the effect of introducing an agreed 13th Priority:

Meet the Island's commitments to address the climate emergency through the implementation of the Carbon Neutral Roadmap.

It also amends the Council of Ministers 12<sup>th</sup> priority to ensure that long-term sustainability is considered in any forthcoming reform of Jersey's Planning service.

The Panel is grateful to the Minister for the Environment for his acceptance of the changes that it was seeking to make and believes that the accommodation reached is a good example of the value that can be added by a good working relationship between Scrutiny and the Executive.

The Panel would refer members to its initial report for the rationale to its amendment.
