**26.02.19:**

During debate on the principles of the draft Law, Deputy M. Tadier of St. Brelade proposed (under Standing Order 83) a reference back of the draft Law to the Minister for Treasury and Resources. This proposal was adopted 26.02.19 [votes – pour: 21; contre: 19; abstain: 0]. The draft Law was therefore referred back to the proposing Minister.
